Note

- 1. In accordance with paragraph 5 of Economic and Social Council resolution 1979/41 of 10 May 1979, the annual report of the Council to the General Assembly is being issued in separate fascicles, which will appear as addenda to the present document. Each fascicle will contain a chapter of the report which will consist of a repertorial summary of the relevant proceedings of the Council in chronological order and will include the text of the resolutions and decisions adopted by the Council on the matter.
- 2. Upon the conclusion of the resumed second regular session of 1980, the repertorial summary sections of the fascicles will be consolidated into a single bound volume, which will also contain the usual annexes. The resolutions and decisions of each session will be published in separate books as parts of Supplement No. 1 to the Official Records of the Council.
- 3. The chapters of the report, with an indication of the addenda in which they will appear, are listed in the table of contents.
