NOTE BY THE SECRETARY-GENERAL-- In accordance with Article 21 of the Convention of 13 July 1931 for Limiting the Manufacture and Regulating the Distribution of Narcotic Drugs, as amended by the Protocol of 11 December 1946, the Secretary-General has the honour to communicate the following legislative texts.

Proclamation No.8 of 1961

AMENDMENT OF THE FIFTH SCHEDULE TO THE MEDICAL, DENTAL AND PHARMACY ACT,
1928 (ACT No. 13 of 1928)

Under the powers vested in me by section sixty-seven of the Medical, Dental and Pharmacy Act, 1928 (Act No. 13 of 1928), read with section ninety-four of the said Act, on the recommendation of the South African Medical and Dental Council and the South African Pharmacy Board, as provided in the said section, I hereby amend the Fifth Schedule to the said Act, as amended by Proclamation No. 392 of 1960^{1/}, as follows:

FIFTH SCHEDULE

Habit-Forming Drugs

- (a) By the substitution for the words "the esters of morphine; the ethers of morphine except codeine (methymorphine), ethylmorphine, pholcodine,^{2/} acetyldihydrocodeine and dihydrocodeine" under the item morphine of the words "the esters and ethers of morphine not specifically named in this Schedule, salts and preparations thereof".
- (b) By the substitution for the words "acetyldihydrocodeine, its salts." of the words "acetyldihydrocodeine, salts and preparations thereof, excluding preparations containing 0.2 per cent or less, other than solutions and dilutions in a liquid or solid inert substance".
- (c) By the substitution for the words "codeine (methymorphine), its salts." of the words "codeine (methymorphine), salts and preparations thereof, excluding preparations containing 0.2 per cent or less, other than solutions and dilutions in a liquid or solid inert substance".
- (d) By the substitution for the words "dihydrocodeine, its salts." of the words "dihydrocodeine, salts and preparations thereof, excluding preparations containing 0.2 per cent or less, other than solutions and dilutions in a liquid or solid inert substance".

- (e) By the substitution for the words "ethylmorphine, its salts." of the words "ethylmorphine, salts and preparations thereof, excluding preparations containing 0.2 per cent or less, other than solutions and dilutions in a liquid or solid inert substance".
- (f) By the substitution for the words "pholcodine, its salts." of the words "pholcodine, salts and preparations thereof, excluding preparations containing 0.2 per cent or less, other than solutions and dilutions in a liquid or solid inert substance".

Proclamation No. 298 of 1962

AMENDMENT OF THE FIFTH SCHEDULE TO THE MEDICAL,
DENTAL AND PHARMACY ACT, 1928 (ACT No. 13 of 1928)

Under the powers vested in me by section sixty-seven of the Medical, Dental and Pharmacy Act, 1928 (Act No. 13 of 1928), read with section ninety-four of the said Act, on the recommendation of the South African Medical and Dental Council and the South African Pharmacy Board, as provided in the said section, I hereby amend the Fifth Schedule to the said Act, as amended by Proclamations Nos. 392 of 1960^{1/} and 8 of 1961^{3/}, as follows:

1. By the substitution for the words "codeine (methyilmorphine), salts and preparations thereof, excluding preparations containing 0.2 per cent or less, other than solutions and dilutions in a liquid or solid inert substance" of the words "codeine (methyilmorphine), salts and preparations thereof, excluding syrupus codeinae phosphatis B.P.C. 1934 and preparations and admixtures containing 2.5 per cent or less of methyilmorphine in association with other medicinal substance, except solutions or dilutions in inert liquid or solid substances".
2. By the substitution for the words "ethylmorphine, salts and preparations thereof, excluding preparations containing 0.2 per cent or less, other than solutions and dilutions in a liquid or solid inert substance" of the words "ethylmorphine (dionine), salts and preparations thereof, excluding preparations and admixtures containing 2.5 per cent or less of ethylmorphine in association with other medicinal substances, except solutions or dilutions in inert liquid or solid substances".
3. By the substitution for the words "acetyldihydrocodeine, salts and preparations thereof, excluding preparations containing 0.2 per cent or less, other than solutions and dilutions in a liquid or solid inert substance" of the words "acetyldihydrocodeine, salts and preparations thereof, excluding

preparations containing 0.2 per cent or less, except solutions and dilutions in an inert liquid or solid substance".

4. By the substitution for the words "dihydrocodeine, salts and preparations thereof, excluding preparations containing 0.2 per cent or less, other than solutions and dilutions in a liquid or solid inert substance" of the words "dihydrocodeine, salts and preparations thereof, excluding preparations containing 0.2 per cent or less, except solutions and dilutions in an inert liquid or solid substance".
5. By the substitution for the words "pholcodine^{2/}, salts and preparations thereof, excluding preparations containing 0.2 per cent or less, other than solutions and dilutions in a liquid or solid inert substance" of the words "pholcodine, salts and preparations thereof, excluding preparations containing 0.2 per cent or less, except solutions and dilutions in an inert liquid or solid substance".
