Report of the Secretary-General pursuant to Security Council resolution 2312 (2016) (S/2017/761)

The President (*spoke in French*): In accordance with rule 37 of the Council's provisional rules of procedure, I invite the representatives of the following countries to participate in this meeting: Austria, Belgium, Bulgaria, Croatia, Cyprus, the Czech Republic, Denmark, Estonia, Finland, Germany, Greece, Ireland, Latvia, Libya, Lithuania, Luxembourg, Malta, the Netherlands, Poland, Portugal, Romania, Slovakia, Slovenia and Spain.

The Security Council will now begin its consideration of the item on its agenda.

Members of the Council have before them document S/2017/827, which contains the text of a draft resolution submitted by the following countries: Austria, Belgium, Bulgaria, Croatia, Cyprus, the Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Ireland, Italy, Japan, Latvia, Lithuania, Luxembourg, Malta, the Netherlands, Poland, Portugal, Romania, Slovakia, Slovenia, Spain, Sweden, Ukraine and the United Kingdom of Great Britain and Northern Ireland.

I wish to draw the attention of Council members to document S/2017/761, which contains the report of the Secretary-General pursuant to Security Council resolution 2312 (2016).

The Council is ready to proceed to the vote on the draft resolution before it. I shall put the draft resolution to the vote now.

The President (*spoke in French*): The draft resolution received 15 votes in favour. The draft resolution has been adopted unanimously as resolution 2380 (2017).
