Citation and commencement

1. These regulations may be cited as the Misuse of Drugs (Licence Fees) (Amendment) Regulations (Northern Ireland) 1983 and shall come into operation on -1st April 1983.

Interpretation

2. The Interpretation Act (Northern Ireland) 1954(c) shall apply to these regulations as it applies to a Measure of the Northern Ireland Assembly.

1. These regulations may be cited as the Misuse of Drugs (Amendment) Regulations (Northern Ireland) 1983 and shall come into operation on 18th July 1983.

2. The Interpretation Act (Northern Ireland) 1954(c) shall apply to these regulations as it applies to a Measure of the Northern Ireland Assembly.

CONTROLLED DRUGS EXCEPTED FROM THE PROHIBITION ON IMPORTATION, EXPORTATION AND POSSESSION AND SUBJECT TO THE REQUIREMENTS OF REGULATION 23

1.—(1) Any preparation of one or more of the substances to which this paragraph applies, not being a preparation designed for administration by injection, when compounded with one or more other active or inert ingredients and containing a total of not more than 100 milligrammes of the substance or substances (calculated as base) per dosage unit or with a total concentration of not more than 2.5 per cent. (calculated as base) in undivided preparations.

(2) The substances to which this paragraph applies are acetyldihydrocodeine, codeine, dihydrocodeine, ethylmorphine, nicocodine, nicodicodine (6-nicotinoyldi hydrocodeine), norcodeine, pholcodine and their respective salts.

2. Any preparation of cocaine containing not more than 0.1 per cent. of cocaine calculated as cocaine base, being a preparation compounded with one or more other active or inert ingredients in such a way that the cocaine cannot be recovered by readily applicable means or in a yield which would constitute a risk to health.

3. Any preparation of medicinal opium or of morphine containing (in either case) not more than 0.2 per cent. of morphine calculated as anhydrous morphine base, being a preparation compounded with one or more other active or inert ingredients in such a way that the opium or, as the case may be, the morphine, cannot be recovered by readily applicable means or in a yield which would constitute a risk to health.

4. Any preparation of dextropropoxyphene, being a preparation designed for oral administration, containing not more than 135 milligrammes of dextropropoxyphene (calculated as base) per dosage unit or with a total concentration of not more than 2.5 per cent. (calculated as base) in undivided preparations.

5. Any preparation of difenoxin (1-(3-cyano-3, 3-diphenylpropyl)-4-phenylpiperidine-4-carboxylic acid) containing, per dosage unit, not more than 0.5 milligrammes of difenoxin and a quantity of atropine sulphate equivalent to at least 5 per cent. of the dose of difenoxin.

6. Any preparation of diphenoxylate containing, per dosage unit, not more than 2.5 milligrammes of diphenoxylate calculated as base, and a quantity of atropine sulphate equivalent to at least 1 per cent. of the dose of diphenoxylate.

7. Any preparation of propiram containing, per dosage unit, not more than 100 milligrammes of propiram calculated as base and compounded with at least the same amount (by weight) of methylcellulose.

8. Any powder of ipecacuanha and opium comprising-

10 per cent. opium, in powder,

10 per cent. ipecacuanha root, in powder, well mixed with 80 per cent. of any other powdered ingredient containing no controlled drug.

9. Any mixture containing one or more of the preparations specified in paragraphs 1 to 8, being a mixture of which none of the other ingredients is a controlled drug.

EXPLANATORY NOTE

This note is not part of the Regulations.)

These regulations amend the Misuse of Drugs (Northern Ireland) Regulations 1974. A new Schedule 1 is substituted, and dextropropoxyphene, suferianil and tilidate are added to Schedule 2. The principal change in Schedule 1 (which also consolidates previous amendments) is the addition of certain preparations of dextropropoxyphene. Consequential revocations are made in the regulations which effected the previous amendments of Schedule 1.

Whereas a draft of this Order has been laid before Parliament on the recommendation of the Advisory Council on the Misuse of Drugs and has been approved by a resolution of each House of Parliament:

Now, therefore, Her Majesty, in pursuance of section 2(2) of the Misuse of Drugs Act 1971(a), is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:—

1. This Order may be cited as the Misuse of Drugs Act 1971 (Modification) Order 1983 and shall come into operation on the expiration of the period of two months beginning with the day on which it is made.

2. Schedule 2 to the Misuse of Drugs Act 1971 (which, as amended(b), specifies the drugs which are subject to control under that Act) shall be amended as follows:—

- (a) in paragraph 1(a) of Part 1 of that Schedule, after the word "Racemorphan" there shall be inserted the word "Sufentanil" and after the word "Thebaine" there shall be inserted the word "Tilidate"; and
- (b) in paragraph 1 of Part III of that Schedule, after the word "Chlorphentermine" there shall be inserted the word "Dextropropoxyphene".

EXPLANATORY NOTE

(This Note is not part of the Order.)

This Order amends Schedule 2 to the Misuse of Drugs Act 1971, which specifies the drugs which are subject to control under the Act. The Order adds Sufentanil and Tilidate to Part I of that Schedule (which specifies Class A drugs), and adds Dextropropoxyphene to Part III (which specifies Class C drugs).

SCHEDULE 1

Regulations 4, 7, 8, 14, 15, 16, 18 and 23

Controlled Drugs Excepted from the Prohibition on Importation, Exportation and Possession and Subject to the Requirements of Regulation 23

1.—(1) Any preparation of one or more of the substances to which this paragraph applies, not being a preparation designed for administration by injection, when compounded with one or more other active or inert ingredients and containing a total of not more than 100 milligrammes of the substance or substances (calculated as base) per dosage unit or with a total concentration of not more than 2.5 per cent. (calculated as base) in undivided preparations.

(2) The substances to which this paragraph applies are acetyldihydrocodeine, codeine, dihydrocodeine, ethylmorphine, nicocodine, nicodicodine (6-nicotinoyldihydrocodeine), norcodeine, pholcodine and their respective salts.

2. Any preparation of cocaine containing not more than 0.1 per cent. of cocaine calculated as cocaine base, being a preparation compounded with one or more other active or inert ingredients in such a way that the cocaine cannot be recovered by readily applicable means or in a yield which would constitute a risk to health.

3. 6. Any preparation of diphenoxylate containing, per dosage unit, not more than 2.5 milligrammes of diphenoxylate calculated as base, and a quantity of atropine sulphate equivalent to at least 1 per cent. of the dose of diphenoxylate.

7. Any preparation of propiram containing, per dosage unit, not more than 100 milligrammes of propiram calculated as base and compounded with at least the same amount (by weight) of methylcellulose.

- 8. Any powder of ipecacuanha and opium comprising-
 - 10 per cent. opium, in powder,
 - 10 per cent. ipecacuanha root, in powder, well mixed with
 - 80 per cent. of any other powdered ingredient containing no controlled drug.

9. Any mixture containing one or more of the preparations specified in paragraphs 1 to 8, being a mixture of which none of the other ingredients is a controlled drug.

EXPLANATORY NOTE

(This Note is not part of the Regulations.)

These Regulations amend the Misuse of Drugs Regulations 1973. A new Schedule 1 is substituted, and dextropropoxyphene, sufentanil and tilidate are added to Schedule 2. The principal change in Schedule 1 (which also consolidates previous amendments) is the addition of certain preparations of dextropropoxyphene. Consequential revocations are made in the instruments which effected the previous amendments of Schedule 1.

The Misuse of Drugs (Notification of and Supply to Addicts) (Amendment) Regulations 1983

In pursuance of sections 10(2)(i), 22(c) and 31 of the Misuse of Drugs Act 1971(a), after consultation with the Advisory Council on the Misuse of Drugs, I hereby make the following Regulations:—

1. These Regulations may be cited as the Misuse of Drugs (Notification of and Supply to Addicts) (Amendment) Regulations 1983 and shall come into operation on 1st April 1984.

2. The Misuse of Drugs (Notification of and Supply to Addicts) Regulations 1973(b) shall be amended by the addition, at the end of Regulation 4(3), of the following sub-paragraph:—

"(c) dipipanone, its salts and any preparation or other product containing dipipanone or its salts.".

EXPLANATORY NOTE

(This Note is not part of the Regulations.)

These Regulations amend the Misuse of Drugs (Notification of and Supply to Addicts) Regulations 1973. The 1973 Regulations contain provision prohibiting doctors, except under licence from the Secretary of State or in certain cases for medical treatment, from supplying or prescribing cocaine or diamorphine (commonly known as heroin) to persons they consider or suspect to be addicted to certain controlled drugs. The present amendment adds dipipanone to cocaine and diamorphine as a substance which is subject to this provision.
