Election of a member of the International Court of Justice: list of nominations by national groups

Note by the Secretary-General

1. By a communication dated 23 February 2018 addressed by the Under-Secretary-General for Legal Affairs and United Nations Legal Counsel on behalf of the Secretary-General to the national groups of the States parties to the Statute of the International Court of Justice, attention was drawn to the vacancy in the Court caused by the resignation of Judge Hisashi Owada (Japan), effective 7 June 2018.
2. In conformity with the provisions of the Statute of the Court, the General Assembly and the Security Council, during the seventy-second session of the Assembly, will elect a judge to serve for the remainder of Judge Owada's term of office, until 5 February 2021. In accordance with Article 5, paragraph 1, of the Statute of the Court, national groups were thus invited to undertake the nomination of persons in a position to accept the duties of a member of the Court and to submit such nominations no later than 16 May 2018.
3. In accordance with Article 7 of the Statute of the Court, the Secretary-General has the honour to submit to the General Assembly and to the Security Council, the name of the candidate nominated by the national groups (see annex).
4. The composition of the Court and the voting procedure to be followed in the General Assembly and in the Security Council are set out in a memorandum by the Secretary-General ([A/72/872-S/2018/487](#)). The curriculum vitae of the candidate is reproduced in a note by the Secretary-General ([A/72/874-S/2018/489](#)).
