- 1. The system of certificates, authorisation and licences for the control of the trade in dangerous drugs, as provided by the laws in existence up to 31 December 1952, has worked satisfactorily during the past year. Trade is not carried on with any place which has not adopted the system of import certificates and licences.

C. MANUFACTURED DRUGS

- X. INTERNAL CONTROL OF MANUFACTURED DRUGS
 - 1. a. The manufacture or conversion of dangerous drugs is not permitted in Barbados.
 - b. The control provided for by Articles 13 and 14 (Chapter V) of the Limitation Convention of 1931 is applied by the Dangerous Drugs Act, 1936.
 - 2. a. Only a person lawfully keeping open shop for the retailing of poisons in accordance with the provisions of section 54 of the Druggists Act, 1894-3, or any person in charge of a laboratory for purposes of research or instruction attached to any college, hospital or other institution approved by the Governor for the purpose, or the government analyst is permitted to keep and import dangerous drugs.
 - b. Hospitals and such parochial medical institutions as are approved by the Governor are exempted under certain conditions from the operation of the Dangerous Drugs Regulations 1932, by the Dangerous Drugs (Exemption) Order, 1940.
 - 3. No manufacture of dangerous drugs is carried out in Barbados.
 - 4. a. There are no wholesalers of dangerous drugs in Barbados.
 - b. The Dangerous Drugs Regulations, made under the provisions of the Dangerous Drugs Act, 1936-3, apply to all persons who are allowed to have dangerous drugs and provide for inspections at any time by the police of other authorised government officials.

Special storage for dangerous drugs is required by the Regulations.

5. No manufacture of or trade in diacetylmorphine is carried on in Barbados. Export was not authorised.

XII. PREPARED OPIUM

The mere possession of prepared opium is illegal in Barbados. No other measures have been considered necessary to control opium smoking. Please see V (i).
