Organization of the session

A. Opening and duration of the session

1. The Open-ended Working Group on Ageing held its ninth working session at United Nations Headquarters from 23 to 26 July 2018. The Working Group held _____ meetings.

10. At the same meeting, in accordance with paragraph (c) (ii) of the decision entitled "Modalities of participation of non-governmental organizations in the work of the Open-ended Working Group on Ageing" (A/AC.278/2011/2, para. 8), the Working Group considered the applications of the non-governmental organizations International Renaissance Foundation and National LGBTI Health Alliance, for which an objection letter from a Member State had been received.

11. Statements were made by the observer for the European Union and representatives of Canada, Ukraine and the Russian Federation.

12. The Working Group then approved the participation of the non-governmental organization International Renaissance Foundation in its work, by a recorded vote of 53 to 14 with 30 abstentions. The voting was as follows:
