Administrative and financial implications of draft resolution IB
recommended by the Second Committee (A/35/616, para.22)

Report of the Fifth Committee

Rapporteur: Mr. Carl C. PEDERSEN (Canada)

1. At its 39th meeting, on 28 November 1980, the Fifth Committee considered the statement submitted by the Secretary-General (A/C.5/35/43) on the administrative and financial implications of draft resolution IB, entitled "Financial support for the United Nations Institute for Training and Research", recommended by the Second Committee in paragraph 22 of its report (A/35/616), as well as the related report of the Advisory Committee on Administrative and Budgetary Questions (A/35/7/Add.13).
2. Statements and comments made in the course of the Committee's discussion of this question are reflected in the summary record of the meeting (A/C.5/35/SR.39).

DECISION OF THE FIFTH COMMITTEE

3. The Fifth Committee decided, by a recorded vote of 85 to 11, with 11 abstentions, to inform the General Assembly that, should it adopt draft resolution IB recommended by the Second Committee in paragraph 22 of its report (A/35/616), an additional appropriation of \$305,700 would be required under a new section 33 of the programme budget for 1980-1981 as a grant-in-aid to UNITAR to meet the deficit for 1980. The question of a grant-in-aid for 1981 should be considered by the Assembly at its thirty-sixth session, in the light the report to be submitted by the Executive Director of UNITAR, pursuant to operative paragraph 4 of draft resolution IB. The voting was as follows:

Against: Bulgaria, Byelorussian Soviet Socialist Republic, Czechoslovakia, German Democratic Republic, Hungary, Mongolia, Poland, Ukrainian Soviet Socialist Republic, Union of Soviet Socialist Republics, United Kingdom of Great Britain and Northern Ireland, United States of America.

Abstaining: Australia, Belgium, Brazil, Chile, Germany, Federal Republic of, Israel, Italy, Japan, New Zealand, Portugal, Spain
