Subject: REIMBURSEMENT FOR TRAVEL BY PRIVATE MOTOR VEHICLE

The annex to the present administrative instruction shows the schedule of rates of reimbursement applicable to different groups of countries for travel by motor vehicle, effective 1 March 1988, and supersedes the annex to administrative instruction ST/AI/224/Rev.1/Amend.2.
