The Permanent Mission of Chad to the United Nations has the honour to notify the Department of Peace Operations of the Secretariat of the United Nations of the readiness of the Government of the Republic of Chad to contribute troops and formed police units to the Multinational Security Support Mission in Haiti, the establishment and deployment of which were decided upon by United Nations Security Council resolution 2699 (2023) dated 2 October 2023.

At the same time, the Permanent Mission of Chad to the United Nations would like to confirm to the Department of Peace Operations that Chad has already increased its capacity in terms of major equipment, self-sustainment and personnel training, while drawing lessons from its participation in the United Nations Multidimensional Integrated Stabilization Mission in Mali (MINUSMA) over the last 10 years.

Whatever the size of the unit, the mission to be carried out on the ground or the deployment deadline, Chad, in view of its contribution to peace operations and its excellent collaboration with the United Nations, stands ready to contribute to the Multinational Security Support Mission.

#### Annex IV

The Permanent Mission of the Commonwealth of the Bahamas to the United Nations has the honour to inform the Secretary-General of the United Nations that the Government of the Commonwealth of the Bahamas has committed to providing security assistance to the Republic of Haiti, in accordance with United Nations Security Council resolution 2699 (2023) and in collaboration with bilateral and regional partners.

As outlined in resolution 2699 (2023), the Multinational Security Support Mission in Haiti has been authorized to provide operational, static and training support to the Haitian National Police in countering gangs and conducting joint security operations. The Bahamas will contribute through the deployment of law enforcement personnel to the Haiti Multinational Security Support Mission. The Bahamian contingent will comprise 150 law enforcement personnel to support efforts to improve security conditions in Haiti and build the capacity of the Haitian National Police and its operational unit, the Haitian Coast Guard Commission.

The Bahamas will provide training, capacity-building and joint planning and exercises through the following framework:

- Joint operations and capacity-building. The contingent will engage in joint security operations and assist in developing the investigative and community policing skills of the Haitian National Police. This effort aims to uphold public safety and order, including arrest and detention procedures, as necessary.
- Maritime, waterside and port security. Bahamian officers will collaborate with the Haitian National Police and the Haitian Coast Guard to bolster maritime, waterside and port security, respectively, ensuring the safe and unhindered delivery of humanitarian aid.

We believe that supporting local ownership of Haiti's national security, inclusive of maritime security, waterside and port security, is essential for Haiti's long-term stability. All operations on land and sea, training, planning and joint exercises by the Bahamian contingent will be in full compliance with international human rights law and international humanitarian law, in order to protect the civilian population receiving assistance and to prevent the loss of life. The Bahamas is committed to ensuring that the Mission is set up in a manner that protects the safety, security and well-being of those deployed and looks forward to agreeing on a status-of-protection agreement for multinational forces with bilateral partners.

Our contribution reaffirms the Bahamas' commitment to supporting stability and respect for human rights in Haiti, particularly facilitating the necessary conditions for holding free and fair elections and the provision of humanitarian assistance by land and sea. This commitment is extended also by the administrative, logistical, financial and security support provided by the Government of the Bahamas to the CARICOM Eminent Persons Group in facilitating political dialogue among Haitian stakeholders.

We value the leadership role that the United Nations continues to play in coordinating international support and solidarity for Haiti and encourage the United Nations to continue to employ its good offices to encourage voluntary contributions and support from individual United Nations Member States.
