**JOINT COMMUNIQUÉ ON
THE ESTABLISHMENT OF DIPLOMATIC RELATIONS BETWEEN
THE COMMONWEALTH OF THE BAHAMAS
AND THE PRINCIPALITY OF MONACO**

The Government of the Commonwealth of The Bahamas and the Government of the Principality of Monaco;

Desirous to promote mutual understanding and strengthen the friendship and cooperation between the two countries;

Guided by the principles and purposes of the United Nations Charter and international law, particularly the respect and promotion of international peace and security, equality among States, due respect for national sovereignty and territorial integrity, independence and international treaties, and non-interference in internal affairs of States;

Have decided to establish diplomatic relations from as of the date of the signing of this Joint Communiqué;

Have agreed that their diplomatic relations are based on the provisions of the Vienna Convention on Diplomatic Relations of 18 April 1961, and the Vienna Convention on Consular Relations of 24 April 1963;

In witness whereof, their Excellencies the Extraordinary and Plenipotentiary Ambassadors, duly authorized by their respective Governments, have signed this Joint Communiqué in English and in French, all the texts being equally authentic.
