1. INTRODUCTION

1. At its 62nd meeting, on 10 December 1982, the Fifth Committee, pursuant to rule 153 of the rules of procedure of the General Assembly, considered the statements by the Secretary-General (A/C.5/37/84, A/C.5/37/68 and A/C.5/37/74) on the administrative and financial implications of draft resolutions F, J and K recommended by the First Committee in paragraph 40 of its report (A/37/667) as well as the related report of the Advisory Committee on Administrative and Budgetary Ouestions (A/37/7/Add.16).

2. Statements and comments made in the course of the Committee's consideration of this item are reflected in the relevant summary record (A/C.5/37/SR.62).

II. DECISIONS OF THE FIFTH COMMITTEE

A. Draft resolution F

3. The Fifth Committee decided, by 83 votes to 2, to inform the General Assembly that, should it adopt draft resolution F recommended by the First Committee in paragraph 40 of its report (A/37/667), an additional appropriation of \$77,400 would be required under section 2 of the programme budget for the biennium 1982-1983. Conference-servicing costs would arise which are estimated, on a full-cost basis, at \$522,800. The actual additional appropriations that might be required in this

respect would be considered in the context of the consolidated statement of total conference-servicing requirements to be submitted to the General Assembly at a later stage during the current session.

4. Statements in explanation of vote were made by the representatives of India and the United States of America.

B. Draft resolution J

5. The Fifth Committee decided, by 79 votes to 1, with 6 abstentions, to inform the General Assembly that, should it adopt draft resolution J recommended by the First Committee in paragraph 40 of its report (A/37/667), an additional appropriation of \$90,700 would be required under section 2 of the programme budget for the biennium 1982-1983. Conference-servicing costs would arise which are estimated, on a full-cost basis, at \$634,500. The actual additional appropriations that might be required in this respect would be considered in the context of the consolidated statement of total conference-servicing requirements to be submitted to the General Assembly at a later stage during the current session.

6. A statement in explanation of vote was made by the representative of the United States of America.

C. Draft resolution K

7. The Fifth Committee decided, without objection, to inform the General Assembly that, should it adopt draft resolution K recommended by the First Committee in paragraph 40 of its report (A/37/667), conference-servicing costs would arise which are estimated, on a full-cost basis, at \$318,300. The actual additional appropriations that might be required in this respect would be considered in the context of the consolidated statement of total conference-servicing requirements to be submitted to the General Assembly at a later stage during the current session.
