### SUPPLEMENTARY REPORT OF THE SECURITY COUNCIL COMMISSION OF INQUIRY ESTABLISHED UNDER RESOLUTION 496 (1981)

Judgement was delivered on 27 July 1982: 2 of the accused (Hoare and Duffy) were found guilty on three of the four counts; 6 on two counts and 34 on only one of the counts; 1 (Dukes) was acquitted on all counts, on the grounds that he had been seriously wounded in the early stages of the fighting at the Seychelles airport and was in no physical or mental condition to participate in the arrangements leading to the hijacking of the plane. 4/ Sentences were subsequently imposed, ranging from 20 years' imprisonment (of which 10 years were suspended) for Michael Hoare to five years' imprisonment (of which 4 1/2 years were suspended) for those convicted on one count only. Leave to appeal was refused.

12/ Following the arrest of the accused in Durban and their transfer to Pretoria where they were detained under section 22 of article 62 of 1966 (authorizing detention of those suspected of terrorist activities or other political offences), all except five were released on 2 December 1981. The five were charged with kidnapping. Subsequently, those released were re-arrested, and all were charged with hijacking.
