**Note by the Secretariat**

The Chairperson of the Committee, who was also the Chairperson of the third inter-committee meeting and the sixteenth meeting of chairpersons of human rights treaty bodies, will inform the Committee about the outcome of these meetings. In addition, the Rapporteur on draft harmonized guidelines, Mr. Kamel Filali, will brief the Committee on this issue. In this connection, the Committee will have before it the report of sixteenth meeting of chairpersons, to which is annexed the report of the third inter-committee meeting..

### **3. Draft guidelines for reports to be submitted by States parties in accordance with article 73 of the Convention**

Under this item, the Committee may wish to prepare guidelines regarding the form and content of reports submitted by the States parties under article 73, paragraph

1, of the Convention. In this connection, the Committee will have before it the draft guidelines on an expanded core document and treaty-specific targeted reports and harmonized guidelines on reporting under the international human rights treaties (HRI/MC/2004/3) prepared by the Secretariat for the third inter-committee meeting and sixteenth meeting of chairpersons of human rights treaty bodies, and a note by the Secretariat containing draft guidelines for reports to be submitted by States parties in accordance with article 73 of the Convention.
