APPOINTMENTS TO FILL VACANCIES IN SUBSIDIARY ORGANS
AND OTHER APPOINTMENTS

International Civil Service Commission: appointment of two members of the Commission

Note by the Secretary-General

- 1. In his note A/38/241 of 27 September 1983, the Secretary-General informed the General Assembly that one member of the International Civil Service Commission had resigned and that, accordingly, the Assembly should include in the agenda of its thirty-eighth session an additional sub-item of item 17 reading as follows:
 - "(i) Appointment of a member of the International Civil Service Commission".
- 2. At its 21st plenary meeting, held on 6 October 1983, the General Assembly decided, on the recommendation of the General Committee, to add the sub-item proposed by the Secretary-General, and to allocate it to the Fifth Committee.
- 3. Subsequently, the Secretary-General received notification of the resignation of a second member of the International Civil Service Commission. The two members that have resigned are:
 - Mr. Anatoly Semënovich Chistyakov (Union of Soviet Socialist Republics) and Mr. Jean-Claude Fortuit (France).
- 4. It will accordingly be necessary for the General Assembly at its current session to appoint one person to fill the unexpired portion of the term of office of Mr. Chistyakov, i.e. until 31 December 1984, and one person to fill the unexpired portion of the term of office of Mr. Fortuit, i.e. until 31 December 1985.
- 5. The appointment of members of the International Civil Service Commission is governed by the provisions of articles 4 and 5 of the Commission's Statute.

Pursuant to these provisions, the Secretary-General has undertaken consultations with Member States through the Chairmen of the various regional groups, with the executive heads of the other organizations, with staff representatives through the Federation of International Civil Servants Associations (FICSA) and the co-ordinating Committee for Independent Staff Unions and Associations (CCISUA), and with the Advisory Committee on Administrative and Budgetary Questions (ACABQ).

6. On the basis of these consultations, the Secretary-General, in his capacity as Chairman of the Administrative Committee on Co-ordination, is now in a position to suggest that the Fifth Committee recommend to the General Assembly the appointment of the following persons to replace Mr. Chistyakov and Mr. Fortuit on the Commission:

Mr. Michèle Auchère for a term expiring on 31 December 1985, and Mr. Valery Vasilyevich Tsybukov for a term expiring on 31 December 1984.
