Provisional calendar of conferences and meetings in the economic, social and related fields for 2010 and 2011

Note by the Secretariat

Summary

In the present note, the Economic and Social Council is invited to approve the calendar of conferences and meetings for 2010 and 2011 in the economic, social and related fields. Information on meetings of related bodies and conferences and meetings of governing bodies of specialized agencies and the International Atomic Energy Agency is also provided. The attention of the Council is drawn to the relevant provisions of General Assembly resolutions 45/264, 46/235, 50/227 and 61/16 on the restructuring and revitalization of the United Nations in the economic, social and related fields, which have been taken into account in the preparation of the calendar.

The Council is invited to consider further the biennialization of the sessions of its subsidiary bodies, in accordance with paragraph 2 (f) (ii) of its resolution 1988/77 and General Assembly resolution 50/206 A.

Attention is drawn to Council decision 1988/103, in which the Council decided to invite the Committee on Conferences to review the Council's draft calendar of conferences and meetings and submit, as appropriate, its recommendations thereon to the Council.

1. The provisional calendar of conferences and meetings in the economic, social and related fields for 2010 and 2011, contained in the annex to the present document, has been prepared in accordance with the relevant General Assembly resolutions, in particular resolutions 37/14 C, 39/68 B and D, 40/243, 41/177, 41/213, 42/207 B, 45/264, 46/235 50/227, 59/145 and 61/16 and the relevant decisions and resolutions of the Economic and Social Council. Attention is drawn to the following decisions of the Council and the Assembly:

(a) That the Council should hold an organizational session not to exceed four days' duration in early February and a resumed organizational session at the end of April for one or two days, and that the Council should hold one substantive session of four weeks to take place in alternate years in New York and Geneva in July (Assembly resolutions 45/264 and 50/227);

(b) That the Council, as a Charter body, is entitled to convene meetings as and when needed, with full substantive support and conference services, and that the Council, beginning with its 2007 session, is entitled to convene additional meetings of up to two weeks in order to facilitate the fulfilment of its newly assigned responsibilities for organizing the annual ministerial reviews and the Development Cooperation Forum and to hold ad hoc meetings, in order to effectively fulfil its mandate under the Charter (General Assembly resolution 61/16);

(c) That all meetings of subsidiary and associated organs should conform to the Council's schedule of meetings and not vice versa (decision adopted at the Council's 1837th meeting, on 28 July 1972, at the fifty-third session);

(d) That the Secretary-General should ensure that meetings of the subsidiary bodies of the Council end at least eight weeks before the session of the Council at which their reports are to be considered (Council resolutions 1982/50, para. 1 (l), and 1988/77, para. 2 (f) (i));

(e) That the subsidiary bodies of the Council, with the exception of the regional commissions, may not create either standing or ad hoc intersessional subsidiary bodies without prior approval of the Council (rule 24, para. 2, of the rules of procedure of the Council);

(f) That the regular sessions of the Economic and Social Commission for Asia and the Pacific, the Economic Commission for Latin America and the Caribbean, the Economic Commission for Africa and the Economic and Social Commission for Western Asia and meetings of their subsidiary bodies may be held away from their headquarters when the commission concerned so decides, subject, in the case of regular sessions of the commissions, to the approval of the Council and the Assembly (Assembly resolution 40/243, sect. I, para. 4 (f));

(g) To adopt, on a regular basis, a biennial cycle of meetings that would correspond to the programme budget cycle, for better administrative control (Council decision 281 (LXIII), para. (b));

(h) That (i) the regular sessions of the functional commissions and standing committees of the Council should normally have a duration of not more than eight working days; and (ii) once the calendar of meetings has been adopted by the Council, no additional meetings involving departures from the biennial cycle of meetings would be authorized during the biennium (Council decision 1979/81, paras. (b) to (d), and Assembly resolution 34/50) and that the waiver to the

headquarters rule contained in Assembly resolution 40/243 would be discontinued in the case of the functional commissions (Assembly resolution 49/221 A);

(i) That, in the future, there should be an intervening period of at least two weeks after the closing of the sessions of relevant intergovernmental bodies and the beginning of the session of the Commission on Sustainable Development, in accordance with the multi-year programme of work of the Commission, and that such intergovernmental bodies and the Commission are encouraged to closely coordinate meeting dates and programmes of work so as to avoid overlap between sessions.

2. The Council's attention is drawn to the decision taken by the Committee on Conferences at its 154th meeting, on 11 March 1981, that, in the future, requests for intersessional departures from the calendar of conferences should only be submitted to the Committee for its consideration if accompanied by a presentation of detailed substantive arguments supporting a proposed change in or an addition to the calendar. The Committee also decided to request the Secretariat to inform the Committee, as far in advance as possible, of the need for a postponement of sessions of United Nations bodies, together with a presentation of the substantive reasons necessitating a delay.

3. The Council may recall that in its decision 1992/214, it decided to grant authority to its Bureau to approve intersessional departures from its approved calendar of conferences and meetings in respect of its subsidiary bodies when the Council was not in session and after consultation with the Committee on Conferences.

4. The Council's attention is drawn to Council decision 1988/103, in which the Council decided to invite the Committee on Conferences to review the Council's provisional biennial calendar of conferences and meetings, beginning with the calendar for 1990-1991, and submit, as appropriate, its recommendations thereon to the Council. The Committee on Conferences is scheduled to meet on 25 June 2009 to review the Council's provisional calendar of conferences and meetings for 2010 and 2011 and may submit recommendations to the Council at its substantive session, to be held from 6 to 31 July 2009.

5. The Council may recall that in paragraph 2 (f) (ii) of its resolution 1988/77, it decided to further consider the biennialization of the sessions of its subsidiary bodies. As approved by the Council in its resolution 2006/49, the United Nations Forum on Forests biennialized its meeting schedules starting from 2007. The other subsidiary bodies of the Council that meet biennially are the Economic Commission for Latin America and the Caribbean, the Economic and Social Commission for Western Asia, the United Nations Group of Experts on Geographical Names and the Committee of Experts on the Transport of Dangerous Goods and on the Globally Harmonized System of Classification and Labelling of Chemicals.

6. The Council may wish to take the opportunity of its review of the provisional calendar to consider further the question of the biennialization of its subsidiary bodies in the context of its review of the mandates, composition, functions and working methods of its functional commissions and expert groups and bodies (see Council resolution 1996/41 and General Assembly resolution 50/227).

7. The Council may recall that the General Assembly in its resolution 62/218 decided to authorize the Committee on the Elimination of Discrimination against

Women to hold three annual sessions of three weeks each, with a one-week pre-sessional working group for each session, for an interim period effective from January 2010, pending the entry into force of the amendment to article 20, paragraph 1, of the Convention, and to authorize three annual sessions of the Working Group on Communications under the Optional Protocol to the Convention. The amendment to article 20 had not yet entered into force at the time of the preparation of the present provisional calendar. For planning purposes, the pattern of meetings of the Committee, its pre-sessional working group and the Working Group on Communications for 2010 and 2011 is reflected in the provisional calendar in accordance with the above authorization by the Assembly in preparation for the possible entry into force of the amendment during the next biennium.

8. The Council may wish to note that the mandates of the Working Group on the Right to Development and the high-level task force on the implementation of the right to development will expire in 2010 and their mandates to meet in 2011 will be subject to renewal by the Human Rights Council in 2010.

9. In its resolution 2008/6, the Council requested the President of the Council to convene the Ad Hoc Open-ended Working Group on Informatics for one more year; the mandate of the Working Group to continue its work in 2010 will be subject to review and approval by the Council at its 2009 substantive session.

10. The Council may wish to be informed that the United Nations Group of Experts on Geographical Names, which is based in New York, is considering holding its twenty-sixth session, to be held in 2011, away from its headquarters in one of the other United Nations duty stations, subject to approval by the Council.

11. Concerning serial number 112 in part A of the annex to the present document, the high-level review meeting on the follow-up to and implementation of the Mauritius Strategy for Further Implementation of the Programme of Action for the Sustainable Development of Small Island Developing States, the Council may recall that in paragraph 17 of resolution 63/213, the General Assembly reaffirmed its decision to review, at its sixty-fifth session, the progress made in addressing the vulnerabilities of small island developing States through the implementation of the Mauritius Strategy for Implementation, and decided to convene a two-day high-level review in September 2010 as a part of its sixty-fifth session. It is the understanding of the Department for General Assembly and Conference Management that the high-level review meeting will be held during the sixty-fifth session of the Assembly and will require two meetings per day, one in the morning and one in the afternoon, for a duration of two days, with conference resources to be provided from those allocated to the Assembly. However, if the modalities of the high-level review meeting exceed the above understanding, the matter will be reported to the Assembly in accordance with rule 153 of its Rules of Procedure.

12. Concerning serial number 174 in part B of the annex to the present document, referring to the Fourth United Nations Conference on the Least Developed Countries and its intergovernmental preparatory committee, the Council may recall that in paragraphs 4 and 5 of resolution 63/227, the General Assembly decided to convene the Fourth United Nations Conference on the Least Developed Countries at a high level in 2011 for a duration of not more than five working days and also decided to convene, towards the end of 2010 and/or early in 2011, an intergovernmental preparatory committee, which would hold no more than two meetings. In paragraph 7 of the same resolution, the Assembly stressed that the

Conference and the preparatory activities should be carried out within the budget level proposed by the Secretary-General for the biennium 2010-2011 and should be organized in the most effective and efficient manner possible. It is the understanding of the Department for General Assembly and Conference Management that the Conference and its preparatory committee will be held in New York in accordance with the headquarters rule specified in paragraph 4 of Assembly resolution 40/243. The Department will absorb the costs for the provision of conference services in New York if the dates of the Conference and its preparatory committee are decided in consultation with the Department and will entail not more than two meetings per day, one in the morning and one in the afternoon, for a duration of five days and two days, respectively. However, if the services required for the Conference and its preparatory committee exceed the above understanding, the matter will be reported to the Assembly in accordance with rule 153 of its Rules of Procedure. If the Conference and its preparatory committee are held away from New York Headquarters, the provisions of paragraph 5 of Assembly resolution 40/243 will apply.

13. In the preparation of the provisional calendar, due regard has been taken of General Assembly resolution 53/208 A, in particular paragraph 11, whereby it was decided that United Nations bodies should be invited to avoid holding meetings on Orthodox Good Friday and that this arrangement should be taken into account when drafting future calendars and meetings. For the next biennium, Orthodox Good Friday occurs on 2 April in 2010 and on 22 April in 2011.
