NOTE BY THE SECRETARY GENERAL – In accordance with the relevant Articles of the International Treaties on Narcotic Drugs and Psychotropic Substances, the Secretary-General has the honour to communicate the following legislative text.

STATUTORY INSTRUMENT

No. 17 of 1975

Customs (Prohibited Imports)(Dangerous Goods) Regulation 1975,

being

A Regulation to amend the Customs (Prohibited Imports) Regulations 1973,^{1/} as amended to date, MADE by the High Commissioner in Council under the Customs Act 1951, as amended to date

1. IMPORTATION OF CERTAIN GOODS PROHIBITED (AMENDMENT OF SECTION 3).

Section 3 of the Principal Regulations is amended by inserting after Paragraph (b) the following paragraph:

"(ba) where the words 'subject to Section 4 (other than Subsection (4) (d), (e), (f) and (g))' appear in the third column of that Schedule opposite to the description of those goods - is prohibited unless the requirements of Section 4 other than Subsection (4) (d), (e), (f) and (g) are complied with;"

2. NEW ITEMS IN SECOND SCHEDULE.
