ADOPTION OF THE AGENDA OF THE SEVENTEENTH REGULAR SESSION, ALLOCATION OF ITEMS, AND ORGANIZATION OF THE SESSION

First report of the General Committee

- 1. The General Committee, at its 148th and 149th meetings held on 19 and 20 September 1962, considered the provisional agenda of the seventeenth session of the General Assembly (A/5150), the supplementary list of items (A/5180 and Add.1 and 2) and four requests for the inclusion of additional items (A/5197, 5198 and addenda, 5218 and 5219), as contained in the memorandum by the Secretary-General relating to the adoption of the agenda and allocation of items (A/BUR/157 and Add.1-2).
- 2. The Secretary-General proposed, in document A/BUR/157/Add.2, that the General Committee should take up, as a matter of priority, the question of the inclusion in the agenda of item 10 of the supplementary list "Agreement between the Republic of Indonesia and the Kingdom of the Netherlands concerning West New Guinea (West Irian)", in view of the desirability of early action by the General Assembly. The Committee recommended the inclusion of the item in the agenda and its allocation to plenary meeting, and submitted a separate report to the Assembly on this item (A/5227).
- 3. A summary of the discussions in the Committee appears in the records of the 148th and 149th meetings (A/BUR/SR.148 and 149).
- 4. The following sub-paragraphs give the decisions of the Committee on those items in regard to which a vote was taken on the question of inclusion:

(b) Item 85 (Question of Hungary)

The Committee decided, by 13 votes to 4, with 4 abstentions, to recommend the inclusion of this item.

Item 36 (b) would be renumbered as a separate item.
