APPOINTMENTS TO FILL VACANCIES IN THE MEMBERSHIP OF
SUBSIDIARY ORGANS OF THE GENERAL ASSEMBLY

Advisory Committee on Administrative and Budgetary Questions

Report of the Fifth Committee

Rapporteur: Mr. Ahmed ABOUL GHETT (Egypt)

1. At its 1716th meeting, on 17 October 1975, the Fifth Committee considered a note by the Secretary-General (A/10151) concerning the vacancies which will occur in the membership of the Advisory Committee on Administrative and Budgetary Questions as a result of the expiration on 31 December 1975 of the terms of office of four of its members.
2. The members of the Fifth Committee had been invited to submit the names of persons who might be recommended to the General Assembly for appointment to the Advisory Committee in accordance with rules 155 and 156 of the rules of procedure of the General Assembly. Six names were submitted for the consideration of the Committee (see A/C.5/1691), two of which were subsequently withdrawn.
3. The Fifth Committee voted by secret ballot to decide on its recommendation. The result of the voting was as follows:

Mr. Rudolf Schmidt	76

Six other persons received a total of 14 votes.

4. Mr. García del Solar (Argentina), Mr. Grodsky (Union of Soviet Socialist Republics), Mr. Stottlemeyer (United States of America) and Mr. Schmidt (Federal Republic of Germany), having received the required majority, were declared recommended for appointment as members of the Advisory Committee on Administrative and Budgetary Questions for a three-year term beginning on 1 January 1976.
