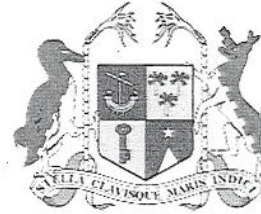

JOINT COMMUNIQUE

ON THE

ESTABLISHMENT OF DIPLOMATIC RELATIONS BETWEEN THE REPUBLIC OF MAURITIUS AND THE REPUBLIC OF HONDURAS

The Government of the Republic of Mauritius and the Government of the Republic of Honduras,

Desirous to promote mutual understanding and to strengthen friendship and cooperation between the two countries,

Guided by the principles and purposes enshrined in the Charter of the United Nations and the principles of international law, particularly international peace and security, respect for State sovereignty and independence, equality among States, as well as respect for international treaties, territorial integrity and non-interference in the internal affairs of other-States,

Have decided to establish diplomatic relations in accordance with the provisions of the Vienna Convention on Diplomatic Relations of the 18th of April 1961, as of the date of signature of this Joint Communiqué,

In witness thereof, the undersigned representatives, duly authorized by their respective Governments, have signed this Joint Communiqué in two originals in English and Spanish both texts being equally authentic.

COMUNICADO CONJUNTO

SOBRE EL ESTABLECIMIENTO DE RELACIONES DIPLOMATICAS ENTRE LA REPUBLICA DE HONDURAS Y LA REPUBLICA DE MAURICIO

El Gobierno de la República de Honduras y el Gobierno de la República de Mauricio,

Con el deseo de promover el entendimiento mutuo y fortalecer la amistad y cooperación entre ambos países,

Guiados por los principios y propósitos enmarcados en la Carta de las Naciones Unidas y los principios de la Ley Internacional, particularmente con el respeto y promoción de paz y seguridad internacional, soberanía estatal e independencia, igualdad entre Estados, así como respeto a tratados internacionales, integridad territorial y la no-intervención en asuntos internos de otros Estados,

Han decidido establecer relaciones diplomáticas en concordancia con las disposiciones de la Convención de Viena sobre Relaciones Diplomáticas del 18 de abril de 1961, a partir de la fecha de firma de este Comunicado Conjunto,

En fe de lo cual, los infrascritos representantes, debidamente autorizados por sus respectivos Gobiernos, han firmado este Comunicado Conjunto en dos originales en inglés y español siendo ambos textos igualmente auténticos.
