DIAZ CISNEROS - Professor Cesar

(Argentina)

Born at La Plata on 16 September 1889.

Finished his law studies in 1910 and became Doctor of Legal and Social Sciences in 1912.

Professor of Public International Law since 1922; holds the same chair since 1926 in the National University of La Plata; was professor of Philosophy, Private International Law and Civic Instruction in other Institutes; has been a member of the Academic Council of the Faculty of Law; was since 1914 judicial officer and subsequently Magistrate; former President of the Civil Division of the Court of Appeals of La Plata; former Minister and President of the Supreme Court of Justice of the Province of Buenos-Ayres; was one of the Vice-Presidents of the National Conference of Advocates of Tucuman (1936).

At present, President of the "Instituto Sanmartiniano", Buenos-Ayres branch; Honorary President of the "Patronato de Liberados" established at La Plata; President of the "Instituto Cultural Argentino-Uruguayo" and Director of the Annals of the Faculty of Legal and Social Sciences.

Headed the delegation of the "Instituto Cultural Argentino-Norteamericano" which visited the United States in 1933; was a delegate at the Conference for the Consolidation of Peace at Buenos-Ayres (1936); plenipotentiary delegate at the Interamerican Conference at Lima (1938). The inter-American treaties signed at both Conferences bear the signature of Dr. Diaz Cisneros.

Was a member of the "Instituto Argentino de Estudios Legislativos" and of the Committee for the Codification of International Law in the Ministry of Foreign Affairs and Religion; President of the Association of Students of Public International Law; former member of the Governing Board of the International Law Association, Argentinian branch; honorary member of the College of Advocates of Lima, etc.

Has given numerous addresses at official University functions; at meetings of the Interamerican Conference of Lima; presided the Sixth Commission of the latter.

He also gave an address on the fiftieth anniversary of the Panamerican Union and on the fiftieth anniversaries of the City of La Plata and of Alberdi.

Plenipotentiary, alternate representative on the Security Council and Interim Committee of the General Assembly of the United Nations.

Professor of Political Science in charge of international law and diplomacy in Yenching University, Peiping, 1923-1937, with the following concurrent appointments: (a) Dean of the College of Public Affairs of the University, 1929-1932; (b) technical adviser to the Chinese delegations to the League of Nations Assembly and Council, 1932-1933; (c) member of the National Defence Planning Commission of the National Government, 1933-1936.

Adviser to the Ministry of Foreign Affairs, 1936 to the present, with the following special assignments: (a) semi-official spokesman for the Ministry on questions relating to international law, 1937-1942; (b) special adviser to the Minister of Foreign Affairs, 1942-1945; (c) technical member of the Chinese delegations to the United Nations San Francisco Conference, Preparatory Commission, General Assembly sessions and the Security Council, and Chinese representative on several General Assembly ad hoc committees, including the Committee on the Progressive Development of International Law and its Codification (1947), 1945-1947; (d) alternate representative to the General Assembly sessions and on the Security Council and Interim Committee of the General Assembly, 1947 to the present.

Author of some thirteen works on Far Eastern international relations, including: "The Manchurian Question", 1929; "The North China Problem", 1937; "Chinese Foreign Relations", 1940.
