SURVEY OF NATIONAL INCOME ESTIMATES FOR 1969-1975

(Memorandum prepared by the Statistical Office)

Introduction

1. In accordance with the terms of reference of the Committee on Contributions, which were established in rule 160 of the rules of procedure of the General Assembly, the expenses of the United Nations should be apportioned "broadly according to capacity to pay". Comparative estimates of national income at market prices for the period under review have been used as a basic guide for the measurement of such capacity. In order to prevent anomalous assessments resulting from the use of comparative estimates of total national income, it is required that comparative estimates of per capita national income and other economic factors also be taken into account.
2. More recently, the General Assembly, by paragraph 4 (b) of its resolution 31/95 A of 14 December 1976, requested the Committee on Contributions to consider the possibility of "mitigating extreme variations in assessments between two successive scales, without departing essentially from the principle of the capacity to pay, either by increasing the statistical base period from three years to some longer period or by any other appropriate method". In light of the foregoing, the data provided in this document cover the period from 1969 to 1975.
3. Annex I of this document, which contains estimates of national income, exchange rates, population and per capita national income of Member States, has been prepared for consideration by the Committee on Contributions at the session to be held in April 1977. Annex II contains estimates of national income, exchange rates, population and per capita national income of States which are not Members of the United Nations but which participate or may participate in certain of its activities.
4. Tables 1 (a) to 1 (d) of annex I show average national income and per capita national income estimates for each country expressed in United States dollars, together with the mid-period population figures used. Four different averages have

been prepared for the consideration of the present session of the Committee: the three-year average from 1972 to 1974 in table 1 (a); the three-year average from 1973 to 1975 in table 1 (b); the four-year average from 1972 to 1975 in table 1 (c); and the seven-year average from 1969 to 1975 in table 1 (d). Table 2 lists the exchange rates used for converting national income estimates expressed in national currencies into estimates in United States dollars for the years 1969 to 1975. Tables 3 (a) to 3 (g) give the four versions of average national income estimates for the current period as shown in tables 1 (a) to 1 (d), average national income estimates for two separate base periods - average 1969 to 1971 and average 1972 to 1974 - and the percentage changes between them; seven different comparisons have been presented. Tables 4 (a) to 4 (g) show similarly per capita national income estimates for the four periods and the two base periods and the percentage changes. The resulting seven comparisons of per capita national income estimates are in the same order as tables 3 (a) to 3 (g). Table 5 lists individual national income estimates expressed in United States dollars for each year from 1969 to 1975.

Sources and nature of available national income estimates

5. For detailed information regarding the sources and nature of national income statistics for each of the countries for which such material is available, as well as for the standard concepts and definitions of national income adopted by the Statistical Office of the United Nations and the adjustments needed for reconciliation of conceptual discrepancies, reference is made to Yearbook of National Accounts Statistics, 1975, volumes I and II, published by the Statistical Office. For a more detailed explanation of concepts, reference is made to A System of National Accounts (SNA) (Studies in Methods, Series F, No. 2, Rev. 3, 1968), 1/ which is a revision and extension of the former A System of National Accounts and Supporting Tables (Studies in Methods, Series F, No. 2, Rev. 2), 2/ prepared by a group of experts appointed by the Secretary-General in July 1952. The standard definitions given in the aforementioned revised System of National Accounts have been used, to the extent possible, as the basis of the national income tables prepared for the Committee. The significant exceptions to the use of these standard definitions are noted in paragraphs 8 to 14 below.

6. At the beginning of this year, the Statistical Office requested all Member States to submit data on national income at market prices for the years 1969 to 1975. A large number of countries have replied and sent in official estimates of national income or related aggregates. The countries may be classified into four groups according to the sources of the data. A broad indication of the sources of the data is shown in the first column of table 5 in annex I. The letter shown there refers to the sources of the original estimates in national currencies. A country is assigned to one of four groups as indicated by the letter in the column. Group A refers to countries which have submitted estimates in reply to the Committee on

Contributions questionnaire or to the United Nations national accounts questionnaire for all years from 1969 to 1975. Group B refers to countries which have submitted estimates for one to six years of the period 1969-1975 and for which estimates for other years were obtained by extrapolation by the Statistical Office. Group C refers to countries which have no official national accounts information for any year from 1969 to 1975 and for which estimates have been prepared by the United Nations regional commissions. Group D refers to countries which have no official national accounts information and for which estimates based on various kinds of economic statistics have been prepared by the United Nations Statistical Office.

7. During recent years, a number of countries have been able to improve the quality and coverage of their estimates of national income and to publish revised estimates of national income based on more adequate material. From national sources of economic statistics, regional economic surveys prepared by the regional commissions and reports of statistical experts provided under the technical co-operation programme valuable information has been obtained, enabling the Statistical Office to improve the methods of estimation for countries for which recent official figures are not yet available. This applies particularly to certain developing countries in Africa, Asia and Latin America. In those cases where extrapolations from previous years were found necessary, the publication of more detailed basic economic and financial statistics has enabled the Statistical Office to arrive at generally better estimates than in previous years. Nevertheless, it must be emphasized that some of the estimates and extrapolations are still to be regarded as tentative and subject to a significant margin of error.

8. The concept of national income used in the centrally planned economies refers mainly to net material product, which excludes the value of services not contributing directly to material production, such as passenger transportation; communication services rendered to the population; public baths, laundries, housing, recreation and entertainment; sanitation services and barber shops; services of teachers, physicians, nurses etc.; administration and defence services; science and research; and banking and insurance. Direct comparison of income aggregates (and components) in the two systems (the system of national accounts, designated SNA, and the material product system, designated MPS) is not possible because of basic differences in the area of economic activity covered by the two systems of national accounts. In SNA, production is defined as the total value of goods and services produced; in MPS, it is restricted to goods and includes only those services which are directly connected with the process of producing goods.

9. Differences in the scope of economic activity included in the two systems can, however, be appreciably reduced when the respective accounts, as distinct from the respective aggregates (and components), are examined. In MPS, the provision of services, although considered non-productive, affects the distribution of the aggregate product. Services thus appear in the widened framework of its national accounts in much the same way as transfer payments appear in SNA. As a result, it is possible to recast the MPS accounts, with certain deviations, in the form of SNA.

10. The problem involved is to estimate the value of "non-material" product in MPS countries, as this area of economic activity is included in the national income

of SNA countries but is, by definition, excluded from material product in the MPS countries. Since, however, non-material product is not a conventional component of the national accounts, the statistical systems of the countries concerned do not provide for it to be calculated, and consequently it has to be derived from a variety of data prepared for other purposes and differing from country to country.

11. The task of estimating non-material product may be regarded in simplified terms as consisting of an estimate of two quantities. The first of these is the sum of the incomes arising in the activities classified as non-material and comprising wages, salaries, profits, interest and taxes. The second is the amount of non-material product already embodied in the material product, such as expenditure on cultural facilities in material sphere included in business cost or financed out of profit, purchases of services by material sphere (scientific services, financial services, insurance services etc.), travel expenditure in material sphere. The difference between these two quantities constitutes the amount of non-material product which has to be added to the material product to achieve identity of coverage with SNA.

12. The amount of the difference between the two systems arising from differences in coverage varies from country to country and cannot therefore be taken as a uniform percentage. The amount of the difference depends not only on stage of economic development but also on economic policy (e.g., the allocation of labour to the various sectors of the economy and price policy as between services and commodities). Further progress in this area would therefore require that MPS countries provide the basic data necessary to estimate quantities involved. In this connexion, it may be noted that four MPS countries have computed estimates of the quantities in question.

13. The reconciliation which is discussed above relates solely to the differences in the coverage of the two systems. A second major source of incomparability arises from differences in the concepts and methods which govern the valuation of the goods and services produced. This is a much more intractable problem, but it should not be regarded as one which vitiates comparisons between MPS countries and those with market economies but rather as a more general problem affecting all international comparisons.

14. Starting with the Committee's session in 1964, the Statistical Office has made estimates of the component elements required to raise net material product estimates of the centrally planned economies to estimates of national income at market prices according to the SNA concept. Over the years, more methodological research on establishing links between the two systems and better availability of data have enabled the Statistical Office to arrive at more reliable estimates of national income at market prices of the centrally planned economies.

Conversion into a common currency unit

15. For purposes of comparison of national income, estimates expressed in national currencies must be converted into a common currency unit, for which the United States dollar has been chosen. During the period from 1971 to 1975,

uncertainties and disturbances of large magnitudes were experienced in the international monetary system of the market economies. The par value régime was gradually discontinued, with the result that the fixed exchange rate system was no longer in operation. A floating exchange rate system took its place. For this reason, in the statistical documents submitted to the present session, as well as those submitted to the last session of the Committee, the procedures used for converting national income in national currencies into United States dollars differ from those used for years prior to 1971, when the fixed exchange rates were commonly used. For the examination of the Committee, exchange rates used for each country for the years 1969 to 1975 are listed in table 2 of annex I of the present document.

16. In preparing the national income estimates of the market economies in United States dollars attached to this memorandum, the Statistical Office used the following procedures. The rates shown for 1969 and 1970 were generally the par value of the currency. For those countries which, during the period from 1971 to 1975, had a single fluctuating exchange rate, the conversion rate used was normally the annual average of market rates published in the International Monetary Fund, International Financial Statistics. Those annual averages were prepared by the International Monetary Fund based on the market rates that were communicated to IMF by the Government of each country. They were annual averages of daily rates in the market of the country or, if those were not available, daily quotations in New York or, if those were not available, end-of-month market rates. In the absence of a free market rate, use was made of the official exchange rate, which is the rate at which a Government is obligated to support, by central bank intervention, its currency in order to maintain a predetermined parity vis-à-vis another currency, such as the United States dollar, the British pound or the French franc. For a few countries, where the use of exchange rates provided by IMF yielded United States dollar estimates which were totally unrealistic, the following procedure was used: national income estimates in national currencies were converted at "adjusted exchange rates", the latter being obtained by adjusting a selected year's exchange rate, believed to represent a reasonable approximation to the purchasing power ratio of the two countries (the country whose figures are converted and the United States), by the ratio of relative price changes of the two countries since the base year. In some instances, national income estimates were made directly in United States dollars on the basis of United States dollars.

17. For the centrally planned economies, the conversion rate used was usually the annual average of effective rates communicated to the Secretariat by the Governments of these countries and published in the United Nations Monthly Bulletin of Statistics.

Method of computation of scale (based on "taxable incomes") 3/

18. In computing the scale (based on "taxable incomes") the Committee, at its last session, used the following method:

(a) A set of national income figures, expressed in United States dollars was established for all Member States;

(b) For those countries for which the average per capita national incomes were below \$1,800 per year, the figures under (a) were reduced in proportion to the difference between the actual per capita national incomes and the figure of \$1,800 mentioned. The difference was expressed as a ratio of \$1,800, and 70 per cent of this ratio was the percentage reduction applied to the national income figure established under (a). 4/

(c) The set of figures thus obtained, called "taxable income", was converted into percentages by setting the total equal to 100 per cent. When at a later stage "ceiling" and "floors" were introduced, the resulting set of percentages was adjusted to yield a total again equal to 100 per cent.

Estimates for non-member States

19. In general the system used for non-member States was the same as for Member States. The "theoretical probable percentages" for non-member States were obtained by relating the taxable incomes of those countries to the combined taxable incomes of the Member States which were not subject to the ceiling or floors, or to nominal assessments, provided, always, that the resulting assessments did not contravene the principle of the floor.

20. Annex II of the present document contains five tables for States which are not Members of the United Nations but which participate or may participate in certain of its activities. Tables 6 (a) to 6 (d) show national income averages for four different periods, the respective per capita national income estimates and mid-period populations. Table 7 lists the exchange rates used for non-member States. Tables 8 (a) to 8 (g) show average national income estimates for the four periods, as well as those for the two base periods and the percentage changes between them. Tables 9 (a) to 9 (g) show similarly average per capita national income estimates for the four periods and for the two base periods and the percentage changes. Table 10 lists individual national income estimates for each year from 1969 to 1975. These constitute a set of tables similar to those shown for Member States and explained in paragraph 4.
