Your Excellency,

The Zionist entity has committed yet another odious crime against the Palestinian people currently engaged in a large-scale people's revolution in protest against the policy of occupation, oppression and aggression and the crimes of genocide to which it is subjected on a daily basis in the occupied Arab territories.

On 29 February 1988, in the village of Qalqiliya in the occupied district of Nablus, Zionist occupation forces set fire to a small hut into which they had pushed 14 Arab citizens, 10 of whom were burnt to death, the other four suffering severe burns.

The crimes of genocide to which the Palestinian people is constantly subjected at the hands of Zionist gangs supported by United States imperialism, as illustrated by the slaughter of children, young people and aged persons, some of whom have been buried alive or had their arms and legs broken, and the commission of every type of act prohibited in all international covenants and conventions, highlight the barbarous Hitlerite methods that the racist Zionist enemy is using to counter the large-scale uprising of the Palestinian people and prevent that people from exercising its legitimate rights to self-determination and the establishment of an independent State covering the whole of its national territory.

Through you, we call upon the international community and world public opinion to adopt a resolute stance, to take measures to deter the Zionist entity from its crimes which have exceeded all the bounds of human imagination, to isolate it internationally and to expel it from the United Nations and all international organizations as an illegal entity based on a policy of occupation, expansion, terrorism, genocide and violations of human rights and all international covenants and conventions.
