




JOINT COMMUNIQUE
ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS

The Government of the Czech Republic and the Government of the Kingdom of Swaziland guided by the principles enshrined in the Charter of the United Nations and desirous of promoting a spirit of mutual understanding and of strengthening the existing bonds of friendship between the peoples of the two countries, have decided to establish diplomatic relations as of the date of signing of this Joint Communique.

Both Governments have agreed to appoint, at a time convenient to both countries, non-resident Ambassadors as their respective representatives.


