# REPORT ON ILLICIT INTERNATIONAL TRAFFIC ON DANGEROUS DRUGS

1. Date of Seizure . . . . . 2nd October 1946.
2. Port of seizure and the department making the seizure . . . . . Bombay, Preventative Department, New Custom House.

8. From whom, how, where, and at what price drugs were obtained by accused, if any. . . . . The accused stated that the Opium was given to him by Wong Sze Kong to take on board S. S. Egorlock for which he was paid Rs.20/- (U.S. \$6.03)

Name: Mohamud Fakir Ahmed, Age: 22 Years, Nationality: Indian; Occupation: Labourer, Build: Lean, Height: 5' - 7", Marks; Eyes oval - a scar 1/2" long between eyes, a scar 1/2" in diameter above left cheek bone and 4 scars (each 4" long on stomach), Residence: No fixed residence, sleeps on foot path Opp. Main Gate, Princess Dock.
