Angola

With our best compliments, we have the honour to transmit the document containing the specimen signatures and stamp of the officials of the Ministry of Commerce and Tourism authorized to sign certificates of origin (Form A) of our exports under the Generalized System of Preferences.

It should be noted that, in the context of the new Organizational Statute of the Ministry of Commerce and Tourism, the National Directorate for International Economic Affairs has been renamed the "Gabinete de Intercâmbio Internacional" (GII) (Office of International Trade). 4/

Bangladesh

Ghana

"Please refer to your telex TD 423/2 of 24 June 1992 on the above subject and find enclosed a sample of the Certificate of Origin from the Ghana National Chamber of Commerce, the certifying authority." 6/
