Chile

"I have the honour to send you herewith current information concerning the Chilean offices authorized to issue certificates of origin under the Generalized System of Preferences." 4/

Lithuania

"Since 15 April 1993 the certificates of origin of goods Form A are issued by eight customs offices of Lithuania. For this reason, we send you impressions of stamps and signs whereby certificates Form A are confirmed and which are in force since that date. The impressions valid before will not be used for confirming certificates in future." 5/

Saint Lucia

"... has the honour to enclose herewith a list of customs officials who are authorized to sign Certificates of Origin (FORM A) under the Generalized System of Preferences on behalf of the Government of Saint Lucia." 6/

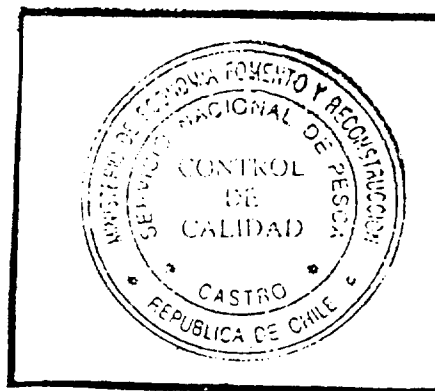

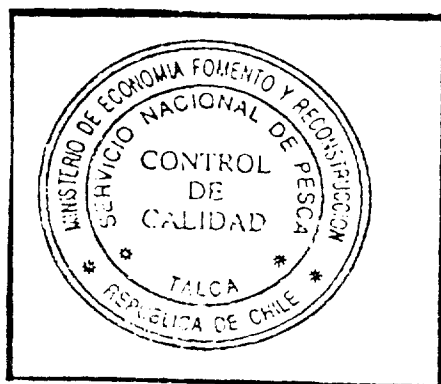
