ENVIRONMENT AND SUSTAINABLE DEVELOPMENT: ELABORATION OF

Note by the Secretary-General

1. In its resolution 48/191 of 21 December 1993, the General Assembly, having considered the note by the Secretary-General concerning the progress of the negotiations on the convention carried out by the Intergovernmental Negotiating Committee for the Elaboration of an International Convention to Combat Desertification in those Countries Experiencing Serious Drought and/or Desertification, particularly in Africa (A/48/226 and Add.1), urged the Intergovernmental Negotiating Committee to complete the negotiations successfully by June 1994, in accordance with resolution 47/188 of 22 December 1993.
2. The General Assembly also requested the Secretary-General to submit to it at its forty-ninth session a report on the implementation of the resolution.
3. The Intergovernmental Negotiating Committee held its third session at Headquarters from 17 to 28 January 1994. The Secretary-General has the honour to submit to the General Assembly, annexed to the present note, the report on that session.

I. INTRODUCTION

Opening and duration of the session

1. The third session of the Intergovernmental Negotiating Committee for the Elaboration of an International Convention to Combat Desertification in those Countries Experiencing Serious Drought and/or Desertification, particularly in Africa, was held in New York from 17 to 28 January 1994. The session was convened in accordance with paragraph 4 of General Assembly resolution 47/188 of 22 December 1992. At its third session, the Committee held three meetings (1st to 3rd), on 17, 24 and 28 January 1994.

IV. ELABORATION OF AN INTERNATIONAL CONVENTION TO COMBAT
DESERTIFICATION IN THOSE COUNTRIES EXPERIENCING
SERIOUS DROUGHT AND/OR DESERTIFICATION, PARTICULARLY
IN AFRICA

A. Reports of the working groups

1. Report of Working Group I

12. At the 3rd meeting, on 28 January, the Vice-Chairman of Working Group I, Mr. Ahmed Djoghlaif (Algeria), introduced the report of Working Group I (A/AC.241/WG.I/L.2), as adopted.

13. At the same meeting, the Committee adopted the report of Working Group I (see annex III, sect. 1).

2. Report of Working Group II

14. At the 3rd meeting, on 28 January, the Chairman of Working Group II, Ms. Anne De Lattre (France), introduced the report of Working Group II (A/AC.241/WG.II/L.2), as adopted.

15. At the same meeting, the Committee adopted the report of Working Group II (see annex III, sect. 2).

V. REVIEW OF THE SITUATION AS REGARDS EXTRABUDGETARY FUNDS

16. At its 2nd and 3rd meetings, on 24 and 28 January, the Committee considered agenda item 3, "Review of the situation as regards extrabudgetary funds". For its discussion of the item, the Committee had before it a note by the Secretariat on the review of the situation as regards extrabudgetary funds (A/AC.241/16 and Add.1).

17. The Executive Secretary made an opening statement in which he presented an account of the voluntary contributions made to both the Special Voluntary Fund for developing countries' participation and the Trust Fund for preparatory activities. He thanked those countries and international organizations which had responded to the appeals for additional funding made during the second session of the Committee. He underlined the difficulties encountered in financing participation at the third session. He also expressed concern about the participation of developing countries at the fourth and fifth sessions: some \$800,000 would be needed in order to maintain the current level of support to one delegate from each of some 70 countries affected by desertification and drought and requesting assistance for their participation. If funding did not reach that level in time, it would be necessary to cut back assistance, probably

by restricting recipients to the least developed countries. Some delegations made comments or sought further clarification on the utilization of the resources available to the Secretariat.

18. In concluding the discussions, the Chairman of the Committee urged Member States to contribute effectively to the funds so as to enable the Secretariat to undertake the activities envisaged in an efficient and timely way.

VI. ADOPTION OF THE PROVISIONAL AGENDA FOR THE FOURTH SESSION
AND ORGANIZATION OF WORK FOR THE FINAL STAGES OF THE
NEGOTIATIONS

A. Adoption of the provisional agenda for the fourth session

19. At its 3rd meeting, on 28 January, the Committee decided to approve the draft provisional agenda for its second session (see annex II, decision 3/2).

B. Future work of the Committee

20. At its 3rd meeting, the Committee agreed to the following points regarding its future work as outlined by the Chairman:

(a) The Secretariat should prepare a revised version of the negotiating text of the Convention (A/AC.241/15/Rev.1) as soon as possible, based on the negotiations at the third session;

(b) The Secretariat should prepare a negotiating text on a regional instrument for Africa based on the elements contained in the note by the Secretariat on possible format and elements of a regional implementation annex for Africa (A/AC.241/17) and on the comments made during the discussion in Working Group II. It was noted that, at that time, some delegations had indicated that they might elaborate their comments in writing and that delegations wishing to do so would have to submit such comments without delay;

(c) It was understood that all questions relating to regional instruments would be considered by the fourth session;

(d) The fourth session should be organized in such a way that the negotiations would be concluded by June 1994, in accordance with General Assembly resolution 48/191.

VII. ADOPTION OF THE REPORT OF THE COMMITTEE
ON ITS THIRD SESSION

21. At its 3rd meeting, on 28 January, the Committee adopted the draft report on its second session, as contained in document A/AC.241/L.16, and authorized the Rapporteur to finalize it in cooperation with the Chairman and the Bureau by incorporating therein the proceedings of the 2nd and 3rd meetings.

Annex III

1. Report of Working Group I

A. Organization of work

1. At its 1st plenary meeting, on 17 January, the Intergovernmental Negotiating Committee, in accordance with its decision 2/1 of 13 September 1993 (see A/48/226/Add.1, appendix II), allocated item 2 of its agenda, entitled "Elaboration of an international convention to combat desertification in those countries experiencing serious drought and/or desertification, particularly in Africa", to the working groups. Working Group I would be responsible for the elaboration of such provisions as the preamble, principles and objectives, commitments, national and regional action programmes, capacity-building, education and public awareness, and financial resources and mechanisms.

2. At the 1st meeting of Working Group I, on 17 January, the Acting Chairman (Benin) made an introductory statement.

3. At the same meeting, the Working Group approved its programme of work for 17 to 28 January 1994. Subsequently it held 16 meetings during that period.

4. Working Group I had before it for its consideration a note by the Secretariat entitled "Negotiating text of the convention" (A/AC.241/15 and Corr.1) prepared on the basis of the text entitled "Compilation of government views, statements and drafting proposals" (A/AC.241/12), containing written submissions from Governments and taking into account statements made at the second session of the Committee.

B. Discussion of topics

1. Preamble

First reading (A/AC.241/15)

5. Working Group I considered the topic at its 1st and 2nd meetings, on 17 and 18 January. Statements were made by the representatives of 50 States, including one speaking on behalf of the Group of African States and one speaking on behalf of the States Members of the United Nations that are members of the European Union.

Second reading (A/AC.241/WG.I/CRP.1)

6. The Working Group continued its consideration of the topic at its 10th and 11th meetings, on 24 and 25 January. It had before it a document entitled "First revision of the preamble, article 2 and article 3" (A/AC.241/WG.I/CRP.1), prepared by the Secretariat on the basis of the discussion resulting from the first reading of the topic.

/...

7. Statements were made by the representatives of 42 States, including one speaking on behalf of the Group of African States and one speaking on behalf of the States Members of the United Nations that are members of the European Union.

8. An observer made a statement.

2. Objectives

First reading (A/AC.241/15)

9. Working Group I considered the topic at its 3rd meeting, on 18 January. Statements were made by the representatives of 31 States, including one speaking on behalf of the Group of African States and one speaking on behalf of the States Members of the United Nations that are members of the European Union.

Second reading (A/AC.241/WG.I/CRP.1)

10. The Working Group continued its consideration of the topic at its 11th meeting, on 25 January. It had before it the document entitled "First revision of the preamble, article 2 and article 3" (A/AC.241/WG.I/CRP.1), prepared by the Secretariat on the basis of the discussion resulting from the first reading of the topic.

11. Statements were made by the representatives of 28 States, including one speaking on behalf of the Group of African States and one speaking on behalf of the States Members of the United Nations that are members of the European Union.

12. An observer made a statement.

3. Principles

First reading (A/AC.241/15)

13. Working Group I considered the topic at its 3rd meeting, on 18 January. Statements were made by the representatives of 20 States, including one speaking on behalf of the Group of African States and one speaking on behalf of the States Members of the United Nations that are members of the European Union.

Second reading (A/AC.241/WG.I/CRP.1)

14. The Working Group further considered the topic at its 11th and 13th meetings, on 25 and 26 January. It had before it the document entitled "First revision of the preamble, article 2 and article 3" (A/AC.241/WG.I/CRP.1), prepared by the Secretariat on the basis of the discussion resulting from the first reading of the topic.

/...

15. Statements were made by the representatives of eight States, including one speaking on behalf of the Group of African States and one speaking on behalf of the States Members of the United Nations that are members of the European Union.

4. Commitments

First reading (A/AC.241/15)

16. Working Group I considered the topic at its 3rd meeting, on 18 January. Statements were made by the representatives of 45 States, including one speaking on behalf of the Group of African States and one speaking on behalf of the States Members of the United Nations that are members of the European Union.

Second reading (A/AC.241/WG.I/CRP.2)

17. The Working Group further considered the topic at its 12th meeting on 25 January. It had before it a document entitled "First revision of part II, general provisions" (A/AC.241/WG.I/CRP.2), prepared by the Secretariat on the basis of the discussion resulting from the first reading of the topic.

18. Statements were made by the representatives of 44 States, including one speaking on behalf of the Group of African States, one speaking on behalf of the States Members of the United Nations that are members of the European Union and on behalf of the Group of 77 and China, and one speaking on behalf of some eastern European and central Asian countries.

19. Statements were made by the observers of two non-governmental organizations.

5. National and regional action programmes

First reading (A/AC.241/15)

20. Working Group I considered the topic at its 5th to 8th meetings on 19 to 21 January. Statements were made by the representatives of 55 States, including one speaking on behalf of the Group of African States and one speaking on behalf of the States Members of the United Nations that are members of the European Union.

21. Statements were made by the representatives of two United Nations specialized agencies. Statements were also made by the representatives of two non-governmental organizations.

Second reading (A/AC.241/WG.I/CRP.3)

22. The Working Group further considered the topic at its 13th, 14th and 16th meetings, on 26 and 27 January. The Working Group had before it the document entitled "First revision of part II, general provisions"

(A/AC.241/WG.I/CRP.3), prepared by the Secretariat on the basis of the discussion resulting from the first reading of the topic.

23. Statements were made by the representatives of 40 States, including one speaking on behalf of the Group of African States and one speaking on behalf of the States Members of the United Nations that are members of the European Union.

24. An observer made a statement. Statements were also made by the observer of an intergovernmental organization and an observer of a non-governmental organization.

6. Capacity-building, education and public awareness

First reading (A/AC.241/15)

25. Working Group I considered these topics at its 8th meeting, on 21 January. Statements were made by the representatives of 26 States, including one speaking on behalf of the Group of African States and one speaking on behalf of the States Members of the United Nations that are members of the European Union.

26. Statements were made by the observers of two non-governmental organizations.

Second reading (A/AC.241/WG.I/CRP.4)

27. The Working Group continued its consideration of the topic at its 15th meeting, on 27 January. It had before it a document entitled "Capacity-building, education and public awareness" (A/AC.241/WG.I/CRP.4), prepared by the Secretariat on the basis of the discussion resulting from the first reading of the topic.

28. Statements were made by the representatives of 34 States, including one speaking on behalf of the Group of African States and one speaking on behalf of the States Members of the United Nations that are members of the European Union.

29. An observer made a statement.

7. Financial resources and mechanisms

First reading (A/AC.241/15)

30. Working Group I discussed the topic at its 9th and 10th meetings, on 21 and 24 January. Statements were made by the representatives of 33 States, including one speaking on behalf of the Group of African States and one speaking on behalf of the States Members of the United Nations that are members of the European Union.

Second reading (A/AC.241/WG.I/CRP.4)

31. The Working Group further considered the topic at its 16th meeting, on 27 January. It had before it a document entitled "Financial resources and mechanisms" (A/AC.241/WG.I/CRP.4), prepared by the Secretariat on the basis of the discussion resulting from the first reading of the topic.

32. Statements were made by the representatives of seven States, including one speaking on behalf of the Group of African States and one speaking on behalf of the States Members of the United Nations that are members of the European Union.

At its 1st plenary meeting, on 17 January, the Intergovernmental Negotiating Committee, in accordance with its decision 2/1 of 13 September 1993 (see A/48/226/Add.1, appendix II), allocated item 2 of its agenda, entitled "Elaboration of an international convention to combat desertification in countries experiencing serious drought and/or desertification, particularly in Africa" to the working groups. Working Group II would be responsible for the elaboration of such provisions as definitions, institutional, administrative, technological and scientific aspects; research, data collection and exchange information; procedural arrangements and other legal provisions such as any instruments relating to the convention.
2. At the 1st meeting of Working Group II, on 17 January, the Chairman made an introductory statement.
3. At the same meeting, the Working Group approved its programme of work for 17 to 28 January 1994. Subsequently it held 18 meetings during that period.
4. Working Group II had before it for its consideration a note by the Secretariat entitled "Negotiating text of the convention" (A/AC.241/15 and Corr.1), prepared on the basis of the "Compilation of government views, statements and drafting proposals" (A/AC.241/12), written submissions from Governments and statements made at the second substantive session of the Committee.

B. Discussion of topics

1. Definitions

First reading (A/AC.241/15, article 1)

5. An informal working group was established to review the definitions of technical terms. It was decided that the results would be examined at the fourth session.
6. Working Group II considered the topic at its 1st and 2nd meetings, on 17 and 18 January. It had before it a note by the Secretariat on the definition of terms relating to the Convention (A/AC.241/L.15 and Corr.1).
7. Statements were made by the representatives of 38 States, including one speaking on behalf of the States Members of the United Nations that are members of the European Union.
8. At the 1st meeting, a statement was made by the representative of a United Nations specialized agency. A statement was also made by the representative of an intergovernmental organization.

Second reading (A/AC.241/WG.II/CRP.1)

9. The Working Group continued its consideration of the topic at its 11th meeting, on 25 January. It had before it a document entitled "Use of terms" (A/AC.241/WG.II/CRP.1), prepared by the Secretariat on the basis of the discussion during the first reading of the topic.

10. Statements were made by the representatives of 27 States, including one speaking on behalf of the Group of African States and one speaking on behalf of the States Members of the United Nations that are members of the European Union.

2. Technology transfer and cooperation

First reading (A/AC.241/15, article 20)

11. Working Group II considered the topic at its 2nd meeting, on 18 January. Statements were made by the representatives of 21 States, including one speaking on behalf of the States Members of the United Nations that are members of the European Union and one speaking on behalf of the Group of African States.

12. At the same meeting, a statement was made by the representative of an intergovernmental organization.

Second reading (A/AC.241/WG.II/CRP.2)

13. The Working Group continued its consideration of the topic at its 12th meeting, on 25 January. It had before it a document entitled "Transfer, acquisition, adaptation and development of technology" (A/AC.241/WG.II/CRP.2), prepared by the Secretariat on the basis of the discussion during the first reading of the topic.

14. Statements were made by the representatives of 29 States, including one speaking on behalf of the States Members of the United Nations that are members of the European Union.

3. Research and development

First reading (A/AC.241/15, article 19)

15. The Working Group discussed the topic at its 3rd meeting, on 18 January. Statements were made by the representatives of 31 States, including one speaking on behalf of the Group of African States and one speaking on behalf of the States Members of the United Nations that are members of the European Union.

16. At the same meeting, a statement was made by the representative of a United Nations specialized agency. A statement was also made by the representative of an intergovernmental organization.

/...

Second reading (A/AC.241/WG.II/CRP.3)

17. The Working Group continued its consideration of the topic at its 13th meeting, on 25 January. It had before it a document entitled "Research and development" (A/AC.241/WG.II/CRP.3), prepared by the Secretariat on the basis of the discussion during the first reading of the topic.

18. Statements were made by the representatives of 27 States, including one speaking on behalf of the States Members of the United Nations that are members of the European Union.

4. Information collection, analysis and exchange

First reading (A/AC.241/15, article 18)

19. Working Group II discussed the topic at its 4th meeting, on 19 January. Statements were made by the representatives of 27 States, including one speaking on behalf of the Group of African States and one on behalf of the States Members of the United Nations that are members of the European Union.

20. A statement was also made by the representative of a United Nations specialized agency.

Second reading (A/AC.241/WG.II/CRP.4)

21. The Working Group continued its consideration of the topic at its 13th and 16th meetings, on 25 and 26 January. It had before it a document entitled "Information collection, analysis and exchange" (A/AC.241/WG.II/CRP.4), prepared by the Secretariat on the basis of the discussion during the first reading of the topic.

22. Statements were made by the representatives of 25 States, including one speaking on behalf of the States Members of the United Nations that are members of the European Union.

5. Institutions

First reading (A/AC.241/15, articles 24-27)

23. The Working Group considered the topic at its 5th to 8th meetings, from 19 to 21 January. Statements were made by the representatives of 50 States, including one speaking on behalf of the Group of African States and one speaking on behalf of the States Members of the United Nations that are members of the European Union.

24. At the 7th and 8th meetings, statements were made by the representatives of two United Nations specialized agencies. At the 8th meeting, a statement was also made by the representative of an intergovernmental organization.

/...

Second reading (A/AC.241/WG.II/CRP.5)

25. The Working Group continued its consideration of the topic at its 16th to 18th meetings, on 26 and 27 January. It had before it a document entitled "Institutions" (A/AC.241/WG.II/CRP.5), prepared by the Secretariat on the basis of the discussion during the first reading of the topic.

26. Statements were made by the representatives of 32 States, including one speaking on behalf of the States Members of the United Nations that are members of the European Union.

6. Procedures

First reading (A/AC.241/15, articles 28-35)

27. Working Group II considered the topic at its 9th and 10th meetings, on 21 and 24 January. Statements were made by the representatives of 25 States, including one speaking on behalf of the Group of African States and one speaking on behalf of the States Members of the United Nations that are members of the European Union.

Second reading (A/AC.241/WG.II/CRP.6)

28. The Working Group continued its consideration of the topic at its 18th meeting, on 27 January. It had before it a document entitled "Procedures and final clauses" (A/AC.241/WG.II/CRP.6), prepared by the Secretariat on the basis of the discussion during the first reading of the topics of procedures and final clauses.

29. Statements were made by the representatives of 17 States, including one speaking on behalf of the States Members of the United Nations that are members of the European Union.

7. Final clauses

First reading (A/AC.241/15, articles 36-42)

30. Working Group II considered the topic at its 10th and 11th meetings, on 24 and 25 January. Statements were made by the representatives of eight States, including one speaking on behalf of the States Members of the United Nations that are members of the European Union.

31. On the basis of the discussion held on the topic, a document entitled "Procedures and final clauses" (A/AC.241/WG.II/CRP.6) was prepared by the Secretariat, which reflected the revisions to articles 36 to 42 proposed as a result of the first reading.

/...

8. Regional instrument for Africa

32. The Working Group considered the topic at its 14th and 15th meetings, on 26 January, and had before it a note by the Secretariat on a possible format and elements of a regional implementation annex for Africa (A/AC.241/17).

33. At the 14th meeting, on 26 January, the Executive Secretary of the Committee made an introductory statement.

34. Statements were made by the representatives of 37 States, including one speaking on behalf of the States Members of the United Nations that are members of the European Union.

35. There was a discussion and exchange of views on the document presented by the Secretariat on the regional instrument for Africa. Representatives thanked the Secretariat for its good work; however, they expressed the need to have a focused, region-specific and flexible instrument. They recognized the complexity of legal aspects relating to regional instruments and the need to maintain a priority on Africa. Representatives expressed the opinion that the document, as presented by the Secretariat, could constitute a basis for all the regional instruments.

36. The Secretariat of the Committee was requested to prepare for the fourth session a first draft of a consolidated text on the regional instrument for Africa, which would take into account the informal paper on an implementation annex for Africa, prepared by the Organization for African Unity, and the observations and proposals made by representatives during their consideration of the topic at the third session.

37. The Working Group concluded that it would also be possible to identify those elements which could be included in other regional instruments.

C. Adoption of report

38. At the 18th meeting, on 27 January, the Vice-Chairman-cum-Rapporteur, Mr. Frederick E. G. Mallya, introduced the draft report (A/AC.241/WG.II/L.2).

39. At the same meeting, the Working Group adopted the draft report as revised and amended.
