Addendum

1. The following working groups, whose mandates are to be established or renewed by the Council at its current session, should be added to paragraph 7:

(a) Working Group of the Subcommission on Prevention of Discrimination and Protection of Minorities on the rights of persons belonging to national or ethnic, religious and linguistic minorities (draft resolution I in the report of the Commission on Human Rights (see E/1995/23, chap. I, sect. A)), to meet for five working days once a year for three years;

(b) Working Group of the Commission on a possible protocol to the Convention on the Rights of the Child on the sale of children (draft resolution V in the report of the Commission), to meet for two weeks prior to the fifty-second session of the Commission;

(c) Working Group of the Commission on a draft optional protocol to the Convention on the Rights of the Child on the involvement of children in armed conflicts (draft resolution VII in the report of the Commission), to meet for two weeks prior to the fifty-second session of the Commission.

2. The Ad Hoc Working Group of Experts of the Commission on Human Rights on Southern Africa has been terminated (Commission on Human Rights resolution 1995/8), and the work of the Group of Three established under the International Convention on the Suppression and Punishment of the Crime of Apartheid has been suspended (Commission resolution 1995/10).
