PROPOSED ORGANIZATIONAL STRUCTURE FOR THE FIRST SESSION OF THE PREPARATORY COMMITTEE FOR THE UNITED NATIONS CONFERENCE ON HUMAN SETTLEMENTS (HABITAT II)

Note by the secretariat

At its meeting held on 10 April 1994, the Bureau of the Preparatory Committee decided to recommend to the Committee the following organization of work:

1. The Preparatory Committee may find it conducive to the efficient conduct of its work during the first session to adopt the specific organizational arrangements set out below:

(a) The Bureau

2. At its organizational session, the Preparatory Committee has elected the following officers to its bureau

3. At its first plenary meeting the Committee will, however, have to elect a new Chairperson.

4. In this regard, the Committee may wish to note that by a note dated 22 February 1994 the Chairman of the Group of Western European and Other States in New York informed the Secretary-General of the United Nations that Canada had withdrawn from the Chairpersonship of the Preparatory Committee for the United Nations Conference on Human Settlements (Habitat II). Subsequently, and by another note dated 3 March 1994, the Chairman of the Group informed the Secretary-General that the Group had endorsed the candidature of Mr. Martti Lujanen of Finland for the office of Chairperson of the Preparatory Committee.

(b) Sessional committees of the whole

5. The Preparatory Committee may find it advisable to establish two sessional committees of the whole. Committee I would be given the responsibility for items 3 (Preparations at the country level) and 4 (Preparations at the regional and global levels) of the provisional agenda and Committee II would be given responsibility for items 5 (Draft Statement of Principles) and 6 (Draft issue papers and the draft format for the programmes and subprogrammes of the plan of action), with the remaining items being considered in Plenary.

6. A proposed time-table for the first session is presented in annex I. A list of agenda items with corresponding documents is presented in annex II.
