ADOPTION OF THE AGENDA AND OTHER ORGANIZATIONAL MATTERS

Status of documentation for the session

Note by the Secretariat

1. By Economic and Social Council resolutions 1979/1 and 1979/69 on the control and limitation of documentation and 1988/77 on the revitalization of the Council, the Council reiterated that the Secretariat should circulate the relevant documentation in all the working languages six weeks before the opening of the sessions of the Council and its subsidiary organs, and invited the Secretariat to take steps to ensure effective compliance with rule 13, paragraph 4, of the rules of procedure of the Council. By resolution 1979/69, the Council requested the Secretariat to inform the Council and its subsidiary bodies, in the relevant annotated agenda, which documents had not been issued in accordance with the six-weeks' rule, with a full explanation of the reasons that prevented their circulation.

2. In view of the schedule of the first session of the Committee on Natural Resources (22 February-4 March 1994), the documentation for that session should have been submitted to the Division for Policy Coordination and Economic and Social Council Affairs by 7 December 1993 and circulated by 11 January 1994.
