REPORT OF THE ECONOMIC AND SOCIAL COUNCIL

Report of the Third Committee

Rapporteur: Mr. Ahmed Yousif MOHAMED (Sudan)

I. INTRODUCTION

1. At its 3rd plenary meeting, on 22 September 1995, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its fiftieth session the item entitled "Report of the Economic and Social Council".
2. At the same meeting, the General Assembly decided to allocate to the Third Committee chapters of the report of the Economic and Social Council (A/50/3) 1/ that were to be considered under the relevant items of the agenda (see A/C.3/50/1).
3. The Third Committee considered the item at its 58th meeting, on 14 December 1995. An account of the Committee's discussion is contained in the summary record of that meeting (A/C.3/50/SR.58).
4. For its consideration of the item, the Committee had before it the report of the Economic and Social Council for the year 1995 (A/50/3).

II. CONSIDERATION OF PROPOSALS

A. Organization of work of the Third Committee and draft biennial programme of work of the Committee for 1996-1997

5. At the 58th meeting, on 14 December, the representative of the Department for Policy Coordination and Sustainable Development introduced and orally revised the note by the Secretariat (A/C.3/50/L.69) entitled "Organization of work of the Third Committee and draft biennial programme of work of the Committee for 1996-1997" (see A/C.3/50/SR.58).

6. At the same meeting, statements were made and questions raised by the representatives of Mongolia, Ecuador, Cuba, Spain, Costa Rica, Brazil, the Islamic Republic of Iran, Mexico, the United Kingdom of Great Britain and Northern Ireland, Ireland, Colombia, Japan, China, Côte d'Ivoire, Sweden, the Dominican Republic, the Russian Federation and India. The representative of the Department for Policy Coordination and Sustainable Development responded to questions raised.

7. Also at the same meeting, the Third Committee decided to recommend to the General Assembly the inclusion in the provisional agenda of its fifty-first and subsequent sessions of a sub-item entitled "Report of the United Nations High Commissioner for Human Rights" under the item entitled "Human rights questions" (see para. 10, draft decision I).

8. At the same meeting, the Committee approved the organization of work and draft biennial programme of work for 1996-1997 as contained in document A/C.3/50/L.69, as orally revised (see para. 10, draft decision II).

B. Report of the Economic and Social Council

9. At the 58th meeting, on 14 December, on the proposal of the Chairman, the Committee decided to recommend to the General Assembly that it take note of the relevant chapters of the report of the Economic and Social Council (see para. 10, draft decision III).

III. RECOMMENDATIONS OF THE THIRD COMMITTEE

10. The Third Committee recommends to the General Assembly the adoption of the following draft decisions:

DRAFT DECISION I

Report of the United Nations High Commissioner for Human Rights

The General Assembly, recalling its resolution 48/141 of 20 December 1993, decides to include in the provisional agenda of its fifty-first and subsequent

sessions a sub-item entitled "Report of the United Nations High Commissioner for Human Rights" to be considered under the item entitled "Human rights questions".

DRAFT DECISION II

Organization of work of the Third Committee and biennial programme of work of the Committee for 1996-1997

The General Assembly, pursuant to its resolutions 45/175 of 18 December 1990 and 46/140 of 17 December 1991, approves the organization of work of the Third Committee and the biennial programme of work of the Committee for 1996-1997, as contained in annexes I and II to the present decision.

ANNEX I

Organization of work of the Third Committee

A. Guidelines concerning time-limits of statements

1. In accordance with rule 106 of the rules of procedure of the General Assembly and paragraph 22 of decision 34/401 on the rationalization of the procedures and organization of the General Assembly, at the beginning of each session, the Chairman of the Third Committee should propose to the Committee the limitation of the time to be allowed to speakers.

2. Further to General Assembly resolutions 45/175 of 18 December 1990 and 46/140 of 17 December 1991, on the rationalization of the work of the Third Committee, statements made by delegations or on behalf of groups of delegations and by Secretariat officials, unless decided otherwise by the Committee at the beginning of the session, should not exceed 15 minutes. This time-limit will have to be applied with a degree of flexibility towards all speakers. With a view to saving time, all speakers are encouraged to exercise self-discipline, in particular delegations associated with group statements. For practical reasons, group statements are encouraged for the first day of the discussion of an item or sub-item. In this connection, it is important to emphasize the timely distribution of documentation in accordance with the rules of procedure of the Assembly, in order to enable delegations to inscribe themselves on the list of speakers at an early stage.

B. Draft resolutions on reports of treaty bodies and reports of the Secretary-General on the status of the treaties

3. Reports of all treaty bodies will be submitted to the General Assembly in accordance with their respective legislative mandates. Substantive resolutions on those reports should be adopted biennially, in accordance with the programme of work of the Third Committee. Where possible, it is recommended that separate draft resolutions on the status of the treaties should not be submitted but should be incorporated in the draft resolution relating to the report of the

treaty body. In alternate years, the Committee should simply take note of the reports unless more substantive action is deemed appropriate.

C. Draft proposals emanating from subsidiary organs of the Economic and Social Council

4. The Economic and Social Council, in transmitting draft proposals to the General Assembly should, to the extent possible, bear in mind the programme of work of the Third Committee.

D. Programme of work

5. An informal meeting of the Third Committee should be held immediately after the election of the members of its Bureau in order to consider the programme of work of the Committee based on a draft to be prepared by the Secretariat and to consider other organizational aspects relating to the Committee's work, especially the status of documentation.

6. The items allocated to the Third Committee for consideration during the fifty-first session of the General Assembly should be taken up in the following order:

- Item 2. Social development, including questions relating to the world social situation and to youth, ageing, disabled persons and the family
- Item 3. Crime prevention and criminal justice
- Item 4. International drug control
- Item 5. Advancement of women
- Item 6. Implementation of the outcome of the Fourth World Conference on Women
- Item 7. Report of the United Nations High Commissioner for Refugees, questions relating to refugees, returnees and displaced persons and humanitarian questions
- Item 8. Promotion and protection of the rights of children
- Item 9. Programme of activities of the International Decade of the World's Indigenous People
- Item 10. Elimination of racism and racial discrimination 2/

2/ Items 10 and 11 are to be discussed jointly. Delegates may make two separate statements, i.e., one on each item, if they so wish.

7. This arrangement may be reviewed at the organizational meeting of the Third Committee, in particular in the light of the status of documentation at that time.

E. Preparation and submission of draft resolutions

8. In drawing up draft resolutions, delegations are requested to adhere to the programme of work of the Third Committee as reproduced below.

9. Delegations are invited to take into account the general guidelines agreed upon in resolutions 45/175 and 46/140 regarding the submission of draft proposals and as set out below: 5/

Item 1. Report of the Economic and Social Council

Matters calling for action by the General Assembly (Third Committee) or brought to its attention
