## INTRODUCTION

1. The present numerical index to administrative issuances lists in alphanumeric order by series symbol, together with date and subject-matter, all issuances at United Nations Headquarters which are current as of 31 October 1995. This publication is issued annually, together with a subject index, under the symbol ST/AI/218/-.
2. Each issue comprises the following three sections:
  - (a) ST/SGB/- series. These bulletins establish Financial Rules, Staff Rules, the organizational structure of the Secretariat and other important decisions of policy. They are issued in the name of the Secretary-General and remain in effect from a given date until specifically superseded or amended;
  - (b) ST/AI/- series. These instructions prescribe instructions and procedures for the implementation of the Secretary-General's bulletins, and they also set forth office practices and procedures to be applied in more than one department of the Secretariat. These instructions remain in effect from a given date until specifically superseded or amended;
  - (c) ST/IC/- series. These circulars deal with matters of general but one-time interest, matters of general interest for a specific period, informational material or requests for staff cooperation.
3. Excluded from this index are circulars of interest or applicability to project personnel, which are issued under the series symbol ST/IC/P/-.
4. It should be noted that the description of the organizational structure contained in section A does not fully reflect current organizational restructuring. Detailed statements of the functions and organization of those offices will be issued in due course. Secretary-General's bulletins ST/SGB/248, ST/SGB/249, ST/SGB/257, ST/SGB/258, ST/SGB/265, ST/SGB/271 and ST/SGB/273 provide further information in this regard.
