### REPORT OF THE ECONOMIC AND SOCIAL COUNCIL

#### Report of the Second Committee

Rapporteur: Mr. Rae Kwon CHUNG (Republic of Korea)

#### I. INTRODUCTION

1. At its 3rd plenary meeting, on 19 September 1997, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its fifty-second session the item entitled "Report of the Economic and Social Council" and to allocate to the Second Committee the relevant chapters of the Council's report.<sup>1</sup>

2. The Second Committee considered the item at its 36th, 37th, 43rd, 47th and 51st meetings, on 11 and 19 November and on 4 and 9 December 1997. An account of the Committee's consideration of the item is contained in the relevant summary records (A/C.2/52/SR.36, 37, 43, 47 and 51). Attention is also drawn to the general debate held by the Committee at its 3rd to 9th meetings, from 13 to 16 October (see A/C.2/52/SR.3-9).

3. For its consideration of the item, the Committee had before it the following documents:

4. At the 36th meeting, on 11 November, the Officer-in-Charge of the Division for Economic and Social Council Support and Coordination of the Department of Economic and Social Affairs made an introductory statement (see A/C.2/52/SR.36).

## II. CONSIDERATION OF DRAFT PROPOSALS

### A. Draft resolutions A/C.2/52/L.28 and L.41

5. At the 43rd meeting, on 19 November, the representative of the United Republic of Tanzania, on behalf of the States Members of the United Nations that are members of the Group of 77 and China, as well as Australia, Canada and New Zealand, introduced a draft resolution entitled "Report of the Committee on Development Planning" (A/C.2/52/L.28), which read:

"The General Assembly,

"Recalling its resolution 46/206 of 20 December 1991 on the report of the Committee for Development Planning and criteria for identifying the least developed countries,

"Taking note of Economic and Social Council decision 1997/223 of 18 July 1997 concerning the recommendation of the Committee for Development Planning that Vanuatu be graduated from the list of the least developed countries,

"Noting further the letter of the Prime Minister of Vanuatu<sup>3</sup> stating the reasons for his position that the review of Vanuatu's status should be deferred to the year 2000,

"Noting also the development of the vulnerability index, in accordance with resolution 51/183 of 16 December 1996, and stressing that the Committee for Development Planning should take fully into account this index in evaluating the status of the least developed countries,

"Taking into account views and comments expressed by delegations during the debate on the report of the Economic and Social Council at the meetings of the Second Committee of the General Assembly on 11 November 1997,

"1. Reaffirms paragraphs 4 and 5 of its resolution 46/206 relating to transitional arrangements;

"2. Welcomes the convening of Working Group III of the Committee for Development Planning at United Nations Headquarters from 17 to 19 December 1997 to review the results of the technical work and the outcome of the expert group meeting, as requested by the General Assembly in its resolution 51/183;

"3. Decides to retain Vanuatu on the list of the least developed countries until further consideration by the Committee for Development Planning during its next review, in the year 2000."

6. At the 47th meeting, on 4 December, the Vice-Chairman of the Committee, Mr. Adel Abdellatif (Egypt), introduced a draft resolution entitled "Report of the Committee on Development Planning" (A/C.2/52/L.41), submitted on the basis of informal consultations held on draft resolution A/C.2/52/L.28.

7. At the same meeting, the Committee adopted draft resolution A/C.2/52/L.41 (see para. 20).

8. Before the adoption of the draft resolution, the representative of Vanuatu made a statement (see A/C.2/52/SR.47).

9. In the light of the adoption of draft resolution A/C.2/52/L.41, draft resolution A/C.2/52/L.28 was withdrawn by its sponsors.

#### B. Graduation from the list of the least developed countries

10. In its decision 1997/223 of 18 July 1997, entitled "Report of the Committee for Development Planning on its thirty-first session", the Economic and Social Council endorsed the recommendations of the Committee for Development Planning at its thirty-first session<sup>4</sup> regarding the list of the least developed countries.

11. At its 47th meeting, on 4 December, on the proposal of the Chairman, the Committee decided to recommend to the General Assembly that it endorse paragraph (b) of Economic and Social Council decision 1997/223 (see para. 21, draft decision I).

#### C. Revision of the General Regulations of the World Food Programme

12. By its decision 1997/217 of 8 July 1997, entitled "Revision of the General Regulations of the World Food Programme", the Economic and Social Council endorsed the revisions contained in the annex to the report of the Executive Board of the World Food Programme,<sup>5</sup> and decided to transmit them to the General Assembly for consideration at its fifty-second session.

13. At its 47th meeting, on 4 December, on the proposal of the Chairman, the Committee decided to recommend to the General Assembly that it endorse the revisions to the General Regulations of the World Food Programme, as contained

in the annex to the report of the Executive Board of the World Food Programme (see para. 21, draft decision II).

D. Report of the Council of the United Nations University

14. By paragraph 3 of its resolution 1997/43 of 22 July 1997, entitled "Report of the Council of the United Nations University", the Economic and Social Council recommended to the General Assembly that it adopt a decision whereby, beginning in 1998, the report of the Council of the United Nations University would be considered directly by the Second Committee of the General Assembly in accordance with its programme of work.

15. At the 47th meeting, on 4 December, on the proposal of the Chairman, the Committee decided to recommend to the General Assembly that it decide that, beginning in 1998, the report of the Council of the United Nations University would be considered directly by the Second Committee, in accordance with its programme of work (see para. 21, draft decision III).

E. Documents relating to the report of the  
Economic and Social Council

16. At its 47th meeting, on 4 December, on the proposal of the Chairman, the Committee decided to recommend to the General Assembly that it take note of documents before it under the item (see para. 21, draft decision IV).

F. Biennial programme of work of the Second  
Committee for 1998-1999

17. At the 51st meeting, on 9 December, the representative of the Secretariat introduced and read out corrections to the draft biennial programme of work of the Second Committee for 1998-1999 (A/C.2/52/L.45, annex).

18. Statements were made and questions raised by the representatives of the Philippines and Benin. The representative of the Secretariat responded to the questions raised (see A/C.2/52/SR.51).

19. At the same meeting, the Committee approved the draft biennial programme of work of the Second Committee for 1998-1999, as orally corrected, and decided to recommend it to the General Assembly for adoption (see para. 21, draft decision V).

III. RECOMMENDATIONS OF THE SECOND COMMITTEE

20. The Second Committee recommends to the General Assembly the adoption of the following draft resolution:

Recalling its resolution 46/206 of 20 December 1991 on the report of the Committee for Development Planning and criteria for identifying the least developed countries,

Taking note of subparagraph (a) of Economic and Social Council decision 1997/223 of 18 July 1997 by which the Council endorsed the recommendation of the Committee for Development Planning that Vanuatu be graduated from the list of the least developed countries,

Taking note also of subparagraph (b) of Economic and Social Council decision 1997/223,

Noting the content of the letter of the Prime Minister of Vanuatu<sup>6</sup> advancing reasons to support his position that the review of Vanuatu's status should be deferred to the year 2000,

Taking note of the decision<sup>7</sup> of the Committee for Development Planning,<sup>8</sup> in accordance with General Assembly resolution 51/183 of 16 December 1996, to examine as part of its work programme for 1997-1998, the report to be prepared by the Secretary-General on the vulnerability index and to consider the usefulness of such an index as a criterion for the designation of the least developed countries in its examination of issues related to improvements to the criteria and methodology for the designation of the least developed countries,

Taking into account statements made by several delegations during the debate on the report of the Economic and Social Council at the meetings of the Second Committee of the General Assembly on 11 November 1997,

1. Reaffirms paragraphs 4 and 5 of its resolution 46/206 relating to transitional arrangements;

2. Welcomes the convening of Working Group III of the Committee for Development Planning in New York from 17 to 19 December 1997 to review the results of the technical work and the outcome of the expert group meeting, as requested by the General Assembly in its resolution 51/183;

3. Decides to postpone its consideration of subparagraph (a) of Economic and Social Council decision 1997/223, in consideration of the views and

recommendations to be submitted by the Committee for Development Planning to the General Assembly at its fifty-third session through the Economic and Social Council, in accordance with paragraphs 9 and 10 of resolution 51/183, on the usefulness of the vulnerability index as a criterion for the designation of the least developed countries, and, without prejudice to the full development and examination of the vulnerability index and its potential application in assessing the graduation of Vanuatu, a small island developing State, from the list of the least developed countries, and to take a decision accordingly.

21. The Second Committee also recommends to the General Assembly the adoption of the following draft decisions:

#### DRAFT DECISION I

##### Graduation from the list of least developed countries

The General Assembly, in accordance with paragraph (b) of Economic and Social Council decision 1997/223 of 18 July 1997, decides that Cape Verde, Maldives and Samoa should graduate from the list of least developed countries at the time of the next review, in 2000, provided that they continue to meet the criteria for graduation at that time.

#### DRAFT DECISION II

##### Revision of the General Regulations of the World Food Programme

The General Assembly, in accordance with Economic and Social Council decision 1997/217 of 8 July 1997, endorses the revisions to the General Regulations of the World Food Programme, as contained in the annex to the report of the Executive Board of the World Food Programme.<sup>9</sup>

#### DRAFT DECISION III

##### Report of the Council of the United Nations University

The General Assembly, in accordance with paragraph 3 of Economic and Social Council resolution 1997/43 of 22 July 1997, decides that, beginning in 1998, the report of the Council of the United Nations University will be considered directly by the Second Committee of the General Assembly, in accordance with its programme of work.
