**REPORT OF THE SECRETARY-GENERAL PURSUANT TO PARAGRAPH 13
OF SECURITY COUNCIL RESOLUTION 1132 (1997)**

1. Following the military coup of 25 May 1997 in Sierra Leone that overthrew the democratically elected Government, and having determined that the situation constituted a threat to international peace and security in the region, on 8 October 1997, the Security Council, acting under Chapter VII of the Charter of the United Nations, adopted resolution 1132 (1997) imposing mandatory sanctions against the military junta in Sierra Leone.

2. In paragraph 11 of the resolution, the Security Council called upon all States and all international and regional organizations to act strictly in accordance with the relevant provisions of the resolution.

3. Under paragraph 13 of the same resolution, the Council requested all States to report to the Secretary-General within 30 days of the date of adoption of the resolution on steps they had taken to give effect to the provisions set out in paragraphs 5 and 6 of the resolution. On 16 October 1997, the Secretary-General transmitted a note verbale to all States, international organizations and specialized agencies requesting them to provide information on steps they had taken to comply with that request.

4. As at 4 February 1998, 37 replies had been received pursuant to paragraph 13 of resolution 1132 (1997). Each of the replies has been issued as a document of the Security Council, as indicated below:
