Note by the Bureau

4. The attention of the Committee is also drawn to the following matters:

(a) Under item 114, entitled "Review of the efficiency of the administrative and financial functioning of the United Nations", the Fifth Committee, during the main part of the fifty-second session, decided to defer consideration of the question of the strengthening of external oversight mechanisms to the resumed fifty-second session and to entrust the Bureau of the Committee to decide on the appropriate time for its future consideration. The Chairman of the Committee will apprise the Committee of the status of the consultations;

(b) Also under item 114, attention is drawn to paragraph 23 of General Assembly resolution 52/12 B of 19 December 1997, by which the Assembly noted that the Secretary-General had submitted the draft Code of Conduct for United Nations Staff (A/52/488) to the General Assembly and agreed to expedite its consideration;

(c) In paragraph 93 of part III of its resolution 52/220 of 22 December 1997, the General Assembly also decided to undertake during its resumed fifty-second session a thorough review of the working methods of the Fifth Committee with a view to rationalizing them and initiating efficiency measures that might enable the Committee to accomplish its tasks on time without resorting to extra meetings at night and on weekends.
