### Status of documentation for the thirty-eighth session

#### Note by the Secretariat

1. In accordance with paragraph 8 of the annex to Economic and Social Council resolution 2008 (LX) of 14 May 1976, the thirty-eighth session of the Committee for Programme and Coordination will be held at Headquarters in two parts: the first part from 1 to 26 June 1998 and the second part from 17 to 28 August 1998.

2. In its resolution 1988/77 of 29 July 1988 on the revitalization of the Economic and Social Council, the Council reiterated that the Secretariat should circulate the relevant documentation in all working languages six weeks before the opening of the sessions of the Council and its subsidiary organs.

3. In resolution 52/214 B of 22 December 1997, the General Assembly reiterated its request to the Secretary-General to ensure that documentation is available in accordance with the six-week rule for the distribution of documents simultaneously in the six official languages of the Assembly and, as outlined in Assembly resolution 50/206 C of 23 December 1995, when a report is late, the reasons for the delay should be indicated when the report is introduced.

4. The General Assembly, in paragraph 24 of its resolution 52/214, requested the Secretary-General to direct all departments to include, where appropriate, the following elements in reports originating in the Secretariat:

- (a) A summary of the report;
- (b) Consolidated conclusions, recommendations and other proposed actions;
- (c) Relevant background information.

5. The General Assembly also decided that all documents submitted to legislative bodies for consideration and action should have conclusions and recommendations in bold print.

6. In view of the dates of the thirty-eighth session of the Committee for Programme and Coordination, the documentation for the session should be circulated by 20 April 1998. The documents to be issued for the thirty-eighth session are listed in the annex to the present note.
