The Vice-Chairman (Antigua and Barbuda) reported on the outcome of informal consultations on policy guidance on adaptation to the operating entity or entities and orally amended a draft text on that subject.

Statements were made by the representatives of Germany (on behalf of the European Community), Mauritius, United States, Malaysia, China, India, Australia, Brazil, Argentina, Cook Islands, Kenya, Canada, New Zealand, Kiribati, Japan, Egypt and Bangladesh.
