
Excellency,

**Joint Communiqué**  
**On the Establishment of Diplomatic Relations**  
**between**  
**The Republic of Honduras**  
**and**  
**The Republic of the Marshall Islands**

The Government of the Republic of Honduras and the Government of the Republic of the Marshall Islands, convinced that the best way to strengthen peace and international security is through understanding, cooperation and friendly relations between nations, have decided to establish diplomatic relations, in accordance with the Principles and Purposes of the Charter of the United Nations and the relevant provisions of the Vienna Convention on Diplomatic Relations.

Both Governments express their confidence that the establishment of diplomatic relations will contribute to the strengthening of mutual cooperation in the areas of common interest, in order to strengthen democracy and peace, based on the principles of international law.

sobre el Establecimiento de Relaciones Diplomáticas

El Gobierno de la República de Honduras y el Gobierno de la República de las Islas Marshall, convencidos de que la mejor manera de fortalecer la paz y la seguridad internacional es mediante el entendimiento, la cooperación y las relaciones amistosas entre las naciones, han decidido establecer relaciones diplomáticas, de conformidad con los Principios y Propósitos de la Carta de las Naciones Unidas y las disposiciones pertinentes de la Convención de Viena sobre Relaciones Diplomáticas.
