SCHEDULE OF WORK OF THE FIFTH COMMITTEE AT THE TWELFTH SESSION

Note by the Chairman

1. In order that the Fifth Committee may deal expeditiously with its heavy agenda, it is desirable that the Committee, at its opening meeting, agree on a tentative plan of work.
2. With that aim in mind, the Chairman submits below suggestions as to the schedule of work for the consideration of the Committee. This schedule takes into account the existing state of documentation, and reflects what appears to be a reasonable grouping of items.
