Land violations committed in January 2021

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
1 January	1550	In occupied Palestinian territory, at the Israeli enemy position east of Markaba, Israeli enemy personnel pointed the cannon of a Merkava tank at Lebanese territory. The tank left in the direction of occupied territory at 1745 hours.
	1645	In occupied Palestinian territory opposite the town of Mays al-Jabal at point B66, an Israeli enemy Hummer vehicle approached. One of the individuals in the vehicle fired two shots at Lebanese territory over Lebanese civilians who were cutting back plants. No one was injured. The patrol left in the direction of occupied territory at 1700 hours.
5 January	1100	From inside the occupied Shab'a Farms, bursts of medium automatic-weapon fire were heard coming from the perimeter of the Ruwaysat al-Alam and Sammaqah positions.
6 January	1300	In Lebanese territory, near United Nations Interim Force in Lebanon (UNIFIL) post 31-1 in Labbunah, the Chinese contingent of UNIFIL detonated nine landmines that had been left behind by the Israeli enemy.
	1400 1630	From inside the occupied Shab'a Farms, the sound of medium automatic-weapon fire was heard coming from the perimeter of the Jabal al-Rus and Ruwaysat al-Alam positions.
7 January	–	In Lebanese territory, near UNIFIL post 31-1 in Labbunah, the Chinese contingent of UNIFIL detonated 14 landmines that had been left behind by the Israeli enemy.
	0300	In occupied Palestinian territory opposite point B46 (Mays al-Jabal), an Israeli patrol consisting of some 20 soldiers approached on foot. The patrol members crossed the technical fence, spread out without violating the Blue Line and pointed their weapons at Lebanese territory. During that time, a Merkava tank pointed its cannon at Lebanese territory from behind the earthen berm near the aforementioned position. The patrol and the tank left in the direction of occupied territory at 0730 hours.
8 January	–	In the town of Rumaysh in Lebanese territory, the Norwegian People's Aid organization detonated seven mines left behind by the Israeli enemy.
	–	In the town of Yarun in Lebanese territory, the Norwegian People's Aid organization detonated 19 mines left behind by the Israeli enemy.
	–	In the town of Bustan in Lebanese territory, the DanChurchAid organization detonated a landmine left behind by the Israeli enemy.
	1305	In Lebanese territory, near UNIFIL post 31-1 in Labbunah, the Chinese contingent of UNIFIL detonated 17 landmines that had been left behind by the Israeli enemy.

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
9 January	1140	From inside the occupied Shab'a Farms near the Israeli enemy Ruwaysat al-Alam position, enemy personnel fired two shots at Lebanese territory outside the town of Kafr Shuba.
11 January	–	In Lebanese territory, near UNIFIL post 31-1 in Labbunah, the Chinese contingent of UNIFIL detonated eight landmines that had been left behind by the Israeli enemy.
	–	In the town of Rumaysh in Lebanese territory, the Norwegian People's Aid organization detonated eight mines left behind by the Israeli enemy.
	–	In the town of Yarun in Lebanese territory, the Norwegian People's Aid organization detonated 25 mines left behind by the Israeli enemy.
	–	In the town of Bustan in Lebanese territory, the DanChurchAid organization detonated two landmines left behind by the Israeli enemy.
	0905	In occupied Palestinian territory opposite the town of Kafr Kila, at the Israeli enemy Jabal al-Tayyarah position, a group of eight individuals in military uniform approached, scouted the area and took photographs of the Lebanese side. They left in the direction of occupied territory at 0935 hours.
	0930	In occupied Palestinian territory opposite the town of Kafr Kila, at the Israeli enemy Jabal al-Tayyarah position, a group of seven individuals in military uniform approached, scouted the area and took photographs of the Lebanese side. They left in the direction of occupied territory at 1000 hours.
	1540	On the outskirts of Kafr Shuba, in the locality of Bastrah near point OP6 of the Indian contingent of UNIFIL, while the herder Hasan Zahrah was tending his herd, an Israeli enemy foot patrol consisting of 12 members abducted him and took him to the Israeli enemy military post of Zabdin. The herd remained on the outskirts of the town. As the patrol returned to the that post, it passed in front of the concrete blocks at the gate of the occupied Shab'a Farms, violating the withdrawal line.
12 January	–	In Lebanese territory, near UNIFIL post 31-1 in Labbunah, the Chinese contingent of UNIFIL detonated six landmines that had been left behind by the Israeli enemy.
	–	In the town of Rumaysh in Lebanese territory, the Norwegian People's Aid organization detonated 14 mines left behind by the Israeli enemy.
	–	In the town of Yarun in Lebanese territory, the Norwegian People's Aid organization detonated 33 mines left behind by the Israeli enemy.
13 January	–	In Lebanese territory, near UNIFIL post 31-1 in Labbunah, the Chinese contingent of UNIFIL detonated 17 landmines that had been left behind by the Israeli enemy.

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
15 January	1430	In occupied Palestinian territory opposite the town of Mays al-Jabal in the Karrum al-Shiraqi area and points B64 and B65, a Merkava tank, a Humvee vehicle and a Defender vehicle belonging to the Israeli enemy approached. Some eight individuals stepped out, and two tanks and the personnel crossed the technical fence and pointed their weapons at Lebanese territory and Lebanese Army personnel. Israeli enemy personnel took up positions behind the earthen berm and pointed their weapons at Lebanese territory. They also launched three smoke bombs, all of which fell between the technical fence and the Blue Line. At 1615, the two tanks and the individual left in the direction of occupied territory, the tanks releasing camouflage smoke as they left.
18 January	1120	In occupied Palestinian territory opposite the town of Kafr Kila, at the Israeli enemy Jabal al-Tayyarah position, a civilian bus approached. Some 20 individuals in civilian clothing stepped out, scouted the area and took photographs of the Lebanese side. They left in the direction of occupied territory at 1140 hours.
21 January	–	In Lebanese territory, near UNIFIL post 31-1 in Labbunah, the Chinese contingent of UNIFIL detonated four landmines that had been left behind by the Israeli enemy.
	1115	In the locality of Bastrah on the outskirts of the town of Kafr Shuba, near the concrete blocks at the entrance to the occupied Shab'a Farms, while a Lebanese Army topographic survey unit was plotting the coordinates of the location at which civilian Hasan Zahrah had been kidnapped by an Israeli enemy patrol on 12 January 2021, two GMC Wranglers vehicle belonging to the Israeli enemy approached from inside occupied territory. Eight individuals stepped out, three of them in civilian clothing, and two of them violated the withdrawal line at two positions, by 1.13 m and 2.10 m respectively. The patrol members pointed their weapons at the members of the Lebanese unit. At 1135 hours, the enemy patrol retreated into the occupied Shab'a Farms.
22 January	–	In Lebanese territory, near UNIFIL post 31-1 in Labbunah, the Chinese contingent of UNIFIL detonated 16 landmines that had been left behind by the Israeli enemy.
23 January	1600	While the herder Isma'il Zahrah, a civilian, was tending to his livestock in the locality of Bastrah on the outskirts of Kafr Shuba, near the concrete blocks at the entrance to the Shab'a Farms gate, an Israeli enemy patrol attempted unsuccessfully to abduct him. The patrol members held back part of the herd, crossing the withdrawal line into liberated Lebanese territory by a distance of 30 m. At 1620 hours, the detained herd returned and the enemy patrol left for the Zabdin barracks inside the occupied Shab'a Farms.
24 January	0730	In occupied Palestinian territory opposite point OP8 and the town of Wazzani, an Israeli enemy patrol consisting of 19 soldiers approached on foot. They opened the gate in the technical fence, crossed the fence and conducted a patrol along the river. At 0750 hours, during the patrol, a herd of cows belonging to the people of the town of Wazzani was seen south of the Blue Line. The patrol took seven cows into occupied territory. The patrol left in the direction of occupied territory at 0800 hours.

	1230	In occupied Palestinian territory, at the Israeli enemy position east of Markaba, Israeli enemy personnel pointed the cannon of a Merkava tank at Lebanese territory. The tank left in the direction of occupied territory at 1745 hours.
	1230 1415	From inside the occupied Shab'a Farms, bursts of medium automatic-weapon fire were heard coming from the perimeter of the Ruwaysat al-Alam position.
25 January	0800	In Lebanese territory, near UNIFIL post 31-1 in Labbunah, the Chinese contingent of UNIFIL detonated 11 landmines that had been left behind by the Israeli enemy.
	1100	In occupied Palestinian territory opposite the town of Kafr Kila, near point B82, four civilian vehicles belonging to the Israeli enemy approached. Some 20 individuals in civilian clothing stepped out, scouted the area and took photographs of the Lebanese side. They left in the direction of occupied territory at 1140 hours.
	2130	An explosion, the cause of which is unknown, was heard inside the occupied Shab'a Farms.
26 January	0800	In Lebanese territory, near UNIFIL post 31-1 in Labbunah, the Chinese contingent of UNIFIL detonated nine landmines that had been left behind by the Israeli enemy.
	0900 1100	Inside the occupied Shab'a Farms, several explosions and bursts of medium-weapon fire were heard.
	1400	In the occupied Palestinian territory opposite the town of Mays al-Jabal and points B64 and BP31 (1), three Merkava tanks and some 35 Israeli enemy personnel approached. Seventeen soldiers and a Merkava tank crossed the technical fence through the gate opposite point B64 without violating the Blue Line, while the second tank positioned itself opposite point B31 and the third tank positioned itself by the emplacement at the enemy's Dahr al-Asi position. Eighteen soldiers crossed the technical fence through a hole in the fence opposite points B31 (2) and B31 (1) without violating the Blue Line. They performed a drill that consisted of pointing their weapons and tank cannons at Lebanese territory and Lebanese Army personnel, and launched three smoke bombs opposite point B64 and three more opposite points B31(1) and B31(2) in order to mount two camouflaged surveillance cameras pointed at Lebanese territory on a steel peg opposite the two points. While they were withdrawing behind the technical fence, they released smoke to camouflage themselves. They all left in the direction of occupied territory at 1530 hours.
	1836	In occupied Palestinian territory in the locality of Ibl al-Qamh opposite the town of Sarda, Israeli enemy personnel fired shots into the air in the direction of Lebanese territory. Their reasons for doing so are unknown.
	2030	Explosions, the cause of which is unknown, were heard inside the occupied Shab'a Farms.

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
27 January	–	In Lebanese territory, near UNIFIL post 31-1 in Labbunah, the Chinese contingent of UNIFIL detonated 15 landmines that had been left behind by the Israeli enemy.
	0700	In occupied Palestinian territory opposite point B46 (Mays al-Jabal), an enemy patrol consisting of two Hummer vehicles, a Defender vehicle, a Merkava tank and nine individuals took up positions behind the earthen berm and pointed their weapons and tank cannon at Lebanese Army personnel. Six patrol members then stepped out from the vehicles and crossed the technical fence without violating the Blue Line. They removed a surveillance camera installed at the site and then moved opposite points BP31(1) and BP31(2) and removed another camera. The patrol left in the direction of occupied territory at 0900 hours.

2 January	0428	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for two minutes, proceeding on its way for some 185 m. Crew members fired a flare shell over Lebanese territorial waters. The launch then left in the direction of occupied Palestinian territorial waters.
3 January	0359	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for two minutes, proceeding on its way for some 129 m. The launch then left in the direction of occupied Palestinian territorial waters.
	0827	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for three minutes, proceeding on its way for some 222 m. Crew members sounded warning sirens. The launch then left in the direction of occupied Palestinian territorial waters.
	1805	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for four minutes, proceeding on its way for some 314 m. Crew members directed a searchlight towards Lebanese territorial waters and sounded warning sirens. The launch then left in the direction of occupied Palestinian territorial waters.

	2045	Off Ra's al-Naqurah, from inside occupied Palestinian territorial waters, an Israeli enemy military launch directed a searchlight towards Lebanese territorial waters.
5 January	0333	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for three minutes, proceeding on its way for some 277 m. Crew members fired two flare shells over Lebanese territorial waters. The launch then left in the direction of occupied Palestinian territorial waters.
	1522	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for five minutes, proceeding on its way for some 333 m. Crew members fired a percussion bomb into Lebanese territorial waters. The launch then left in the direction of occupied Palestinian territorial waters.
	2235	Off Ra's al-Naqurah, from inside occupied Palestinian territorial waters, an Israeli enemy military launch fired a flare shell over Lebanese territorial waters.
6 January	0359	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for three minutes, proceeding on its way for some 200 m. Crew members fired a flare shell over Lebanese territorial waters. The launch then left in the direction of occupied Palestinian territorial waters.
	1610	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for three minutes, proceeding on its way for some 130 m. The launch then left in the direction of occupied Palestinian territorial waters.
	1703	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for two minutes, proceeding on its way for some 222 m. Crew members fired a flare shell over Lebanese territorial waters. The launch then left in the direction of occupied Palestinian territorial waters.
	1750	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for five minutes, proceeding on its way for some 240 m. Crew members fired two flare shells over Lebanese territorial waters and fired several rounds at Lebanese fishing boats. The launch then left in the direction of occupied Palestinian territorial waters.
	1816	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for six minutes, proceeding on its way for some 370 m. Crew members fired a flare shell over Lebanese territorial waters, directed a searchlight towards Lebanese territorial waters and sounded warning sirens. The launch then left in the direction of occupied Palestinian territorial waters.

	1350	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for one minute, proceeding on its way for some 206 m. The launch then left in the direction of occupied Palestinian territorial waters.
	1540	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for three minutes, proceeding on its way for some 222 m. The launch then left in the direction of occupied Palestinian territorial waters.

The crew fired a flare shell, sounded warning sirens and directed a searchlight towards Lebanese territorial waters. The launch then left in the direction of occupied Palestinian territorial waters.
9 January	2130	In occupied Palestinian territory opposite Ra's al-Naqurah, Israeli enemy personnel directed a searchlight towards Lebanese territorial waters.
11 January	1822	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for 58 minutes, proceeding on its way for some 185 m. The launch then left in the direction of occupied Palestinian territorial waters.

	0435	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for four minutes, proceeding on its way for some 130 m. Crew members fired two flare shells over Lebanese territorial waters. The launch then left in the direction of occupied Palestinian territorial waters.
13 January	0002	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for three minutes, proceeding on its way for some 166 m. 	0005	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for five minutes, proceeding on its way for some 700 m. Crew members fired a flare shell over Lebanese territorial waters. The launch then left in the direction of occupied Palestinian territorial waters.
	0230	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for five minutes, proceeding on its way for some 700 m. Crew members fired two flare shells over Lebanese territorial waters. The launch then left in the direction of occupied Palestinian territorial waters.
	0850	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for five minutes, proceeding on its way for some 300 m. It came across a Lebanese fishing boat in Lebanese territorial waters. Crew members sounded warning sirens for one minute. The launch then left in the direction of occupied Palestinian territorial waters, and the fishing boat headed north in the direction of Tyre.
	2135	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for two minutes, proceeding on its way for some 203 m. Crew members fired a flare shell over Lebanese territorial waters. The launch then left in the direction of occupied Palestinian territorial waters.
	2135	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for five minutes, proceeding on its way for some 700 m. Crew members fired a flare shell over Lebanese territorial waters. The launch then left in the direction of occupied Palestinian territorial waters.

Crew members sounded warning sirens and broadcast in Hebrew over loudspeakers. The launch then left in the direction of occupied Palestinian territorial waters.
	2215	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for two minutes, proceeding on its way for some 148 m. The launch then left in the direction of occupied Palestinian territorial waters.
23 January	0512	Off Ra's al-Naqurah, from inside occupied Palestinian territorial waters, an Israeli enemy military launch fired a flare shell and directed a searchlight at Lebanese territorial waters for one minute.

24 January	0410	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for 10 minutes, proceeding on its way for some 130 m. Crew members fired two flare shells over Lebanese territorial waters. The launch then left in the direction of occupied Palestinian territorial waters.
	1340	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) as follows: <ul style="list-style-type: none"> – At 1340 hours, for five minutes and a distance of approximately 278 m.
