**JOINT COMMUNIQUE**  
**ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS BETWEEN THE REPUBLIC**  
**OF UGANDA AND THE REPUBLIC OF PERU**

The Government of the Republic of Uganda and the Government of the Republic of Peru,

Desirous to promote mutual understanding and strengthen the friendship and cooperation between the two countries,

Guided by the principles and purposes of the United Nations Charter and International Law, particularly on the respect for and promotion of international peace and security, equality among States, due respect for national sovereignty, and territorial integrity, independence and international treaties, and noninterference in the internal affairs of States,

Have decided to establish diplomatic relations in accordance with the provisions of the Vienna Convention on Diplomatic Relations of April 18, 1961, and the Vienna Convention on Consular Relations of 1963, as of the date of the signing of this Joint Communiqué.

In witness thereof, the undersigned Representatives, duly authorized by their respective Governments, have signed this Joint Communiqué in two original copies, in the English and Spanish languages, both texts being equally authentic.

### COMUNICADO CONJUNTO

#### SOBRE EL ESTABLECIMIENTO DE RELACIONES DIPLOMÁTICAS ENTRE REPÚBLICA DEL PERÚ Y LA REPÚBLICA DE UGANDA

El Gobierno de la República del Perú y el Gobierno de la República de Uganda,  
Deseosos de promover el entendimiento mutuo, y fortalecer la amistad y la  
cooperación entre los dos países,

Guiados por los principios y propósitos de la Carta de las Naciones Unidas y el  
Derecho Internacional, en particular sobre el respeto y la promoción de la paz y  
la seguridad internacionales, la igualdad entre los Estados, el debido respeto a la  
soberanía nacional y la integridad territorial, la independencia y los tratados  
internacionales, y no injerencia en los asuntos internos de los Estados,

Han decidido establecer relaciones diplomáticas, de conformidad con las  
disposiciones de la Convención de Viena sobre Relaciones Diplomáticas del 18 de  
abril de 1961 y la Convención de Viena sobre Relaciones Consulares de 1963, a  
partir de la fecha de la firma del presente Comunicado Conjunto.

En fe de ello, los Representantes abajo firmantes, debidamente autorizados por  
sus respectivos Gobiernos, han firmado este Comunicado Conjunto en dos copias  
originales, en los idiomas español e inglés, siendo ambos textos igualmente  
auténticos.
