## **Expenses incurred and reimbursement received by the United Nations in connection with assistance provided to the International Criminal Court**

### **Report of the Secretary-General**

#### *Summary*

The present report is submitted pursuant to paragraph 19 of General Assembly resolution [75/3](#), in which the Assembly emphasized the need for the Secretary-General to inform the Assembly at its seventy-sixth session of the expenses incurred and reimbursements received by the United Nations in connection with assistance provided to the International Criminal Court.

1. During the period from 1 July 2020 to 30 June 2021, the United Nations provided facilities and services to the International Criminal Court in the amount of \$188,211. These included costs for staff who worked exclusively on matters pertaining to the Court; field security and observer fees for the Task Force on Accounting Standards of the High-level Committee on Management; conference and related services; library services; language interpretation services; and registration fees for the language proficiency examination.
2. Additional services in the amount of \$297,303 were provided to the Court by the United Nations Multidimensional Integrated Stabilization Mission in Mali, the United Nations Office at Geneva, the United Nations Support Mission in Libya, the African Union-United Nations Hybrid Operation in Darfur, the United Nations Organization Stabilization Mission in the Democratic Republic of the Congo and the United Nations Multidimensional Integrated Stabilization Mission in the Central African Republic.
3. The Court regularly reimbursed the United Nations upon receipt of invoices.
4. Itemized details of the facilities and services provided to the Court by the United Nations during the period from 1 July 2020 to 30 June 2021 are provided in annex I, and to the Court by the various offices away from Headquarters for the same period in annex II.
