Report of the Secretary-General

Summary

The present report, submitted pursuant to General Assembly resolution [74/53](#), contains information received from Member States on the export and import of conventional arms covered by the United Nations Register of Conventional Arms, as well as information on their international transfers of small arms and light weapons, in accordance with the “seven-plus-one formula” referred to in paragraph 3 of the same resolution and the recommendation contained in paragraph 83 of the group of governmental experts, on the continuing operation of the United Nations Register of Conventional Arms and its further development ([A/71/259](#)).

The report also contains additional background information received from Member States on military holdings and procurement through national production for the calendar year 2020. As at the date of submission of the present report, the Secretary-General had received reports from 34 Governments.

I. Introduction

1. The present report is the twenty-ninth consolidated report on the United Nations Register of Conventional Arms issued by the Secretary-General since the establishment of the Register.¹ The General Assembly, in its resolution 74/53, called upon Member States to provide, on an annual basis, their data and information on international transfers of major conventional arms covered by the Register, including “nil reports”, as well as information on their national procurement of arms and military holdings, as part of additional background information.
2. The General Assembly, in its resolution 71/44, called upon Member States to submit their views on the continuing operation of the Register and its further development, including on whether the absence of small arms and light weapons as a main category in the Register has limited its relevance and directly affected decisions on participation, by completing a questionnaire that was dispatched by the Secretariat. Furthermore, the Assembly requested the Secretary-General to continue to assist Member States to build capacity to submit meaningful reports and encouraged States in a position to do so to provide assistance for this purpose, upon request, including capacity to report on small arms and light weapons using the seven-plus-one formula.
3. On 18 February 2021, the Secretariat sent a note verbale to Member States in which they were requested to submit their reports. The note verbale was followed by email reminders. The replies received are reproduced in section II of the present report. Any national reports and additional information received from Governments after the submission of the report will be made available in the online database, in the original language of submission.
4. The percentage of Member States using the online reporting tool in filing their national reports with the Register has been rising since its introduction in 2012, from 20 per cent that year to more than 99 per cent in 2021.
5. The originals of the submissions by Member States are made available to Governments by the Secretariat. The annual reports and other relevant information on the Register are available on the website of the Register.²

Three Principles on Transfer of Defence Equipment and Technology

While maintaining its basic philosophy as a peace-loving nation that conforms to the Charter of the United Nations and the course it has taken as a peace-loving nation, Japan will control the overseas transfer of defence equipment and technology based on the Three Principles on Transfer of Defence Equipment and Technology. The main contents of the Principles are as follows:

(a) Clarification of cases where transfers are prohibited (the first Principle): overseas transfer of defence equipment and technology will not be permitted when:

- (i) The transfer violates obligations under treaties and other international agreements that Japan has concluded;
- (ii) The transfer violates obligations under Security Council resolutions; or
- (iii) The defence equipment and technology is destined for a country party to a conflict (a country against which the Security Council is taking measures to maintain or restore international peace and security in the event of an armed attack).

(b) Limitation to cases where transfers may be permitted as well as strict examination and information disclosure (the second Principle): in cases not within (a) above, cases where transfers may be permitted will be limited to the following cases. Those cases will be examined strictly while ensuring transparency. The transfer contributes:

- (i) To active promotion of peace contribution and international cooperation; or
- (ii) Japan's security.

Significant cases that require especially careful consideration from the viewpoint of Japan's security will be examined at the National Security Council. As for the cases that were deliberated at the National Security Council, the Government will disclose their information in accordance with the Act on Access to Information Held by Administrative Organs (Law No. 42 of 1999).

(c) Ensuring appropriate control regarding extra-purpose use or transfer to third parties (the third Principle): in cases satisfying (b) above, overseas transfer of defence equipment and technology will be permitted only in cases where appropriate control is ensured. More concretely, the Government will, in principle, oblige the Government of the recipient country to gain its prior consent regarding extra-purpose use and transfer to third parties.

National regulations and international treaties and conventions

The Law on Foreign Trade in Weapons and Military Equipment (“Official Journal of Montenegro”, No. 40/16) and the Law for Control Export of Dual-Use Goods (“Official Journal of Montenegro”, No. 30/12) and the related by-laws provide a basis for the State control of foreign trade in arms, military equipment and dual-use goods (hereinafter referred to as controlled goods). Montenegro has constantly supported the application of all international instruments regulating the field of disarmament and arms control; it recognizes each new and constructive initiative aimed at building and increasing international cooperation in order to reduce and eliminate risks and consequences of production and use of any weapons and ammunition. With regard to the process of foreign trade controls of arms, military equipment and dual-use goods, Montenegro is observing more comprehensive criteria, compared with those envisaged by the Arms Trade Treaty, which Montenegro ratified in July 2014. Having in mind that each contribution to the responsible control of export, import and transfer of weapons adds to both regional and global security, Montenegro found itself among the first countries to accede to the Arms Trade Treaty, thus ratifying the Treaty by adopting the Law on Ratification of the Arms Trade Treaty (“Official Journal of Montenegro – International Treaties”, No. 9/2014 of 4 August 2014). During 2015, Montenegro submitted a request to join the Wassenaar Arrangement and expects access to this regime soon.

Policy changes towards specific destinations

Changes to government policy on general transit licences NL007 and NL008 vis-à-vis Turkey and Ukraine

In October 2019, the Dutch Government tightened its arms export policy with regard to Turkey. This policy decision follows on from the conclusions of the Foreign Affairs Council of October 2019 in which European Union countries jointly agreed to prevent the use of European Union military goods in north-eastern Syria. In order to prevent “less sensitive” military goods, of the type covered by the Ministerial Order for General Transit Licence NL007 and the Ministerial Order for General Transit Licence NL008, from being exported to Turkey and used in the conflict in north-eastern Syria, these ministerial orders will be amended, and Turkey will no longer be an allowable country of final destination. In addition, this amendment of the Ministerial Orders for General Transit Licence NL007 and NL008 seeks to bring monitoring of goods in transit under these general licences more in line with the monitoring of goods in transit under individual licences. For some time now, there has also been heightened monitoring of the export and transit of military goods to Ukraine under individual licences. This monitoring is now being expanded to include the transit of goods under this general licence. In addition to Turkey and Ukraine, the following countries are excluded as final destinations for the NL007 licence: Yemen, Saudi Arabia, the United Arab Emirates and Egypt. These changes to general transit licences NL007 and NL008 do not alter the fact that, for every transit shipment, including those from the above countries, an application can be submitted for an individual transit licence, including for “less sensitive” military goods. Standing government policy will also be followed in this regard. The ministerial order setting out these changes was published in the Government Gazette on 27 October 2020 (Dutch: <https://zoek.officielebekendmakingen.nl/stcrt-2020-55420.html>).

Stricter arms export policy for Hong Kong

On 9 October 2020, in response to the adoption of the new national security law in Hong Kong, the Dutch Government decided to tighten the Netherlands’ arms export policy. From that date, all licence applications for the export of military goods to Hong Kong will be assessed in accordance with the same standards as applications for the rest of the People’s Republic of China. In addition, the European Union arms embargo currently in effect for China will now be applied by the Netherlands to exports to Hong Kong. Amendment of Law on Export Control of Defence and Dual-Use equipment and technology – post-shipment verification procedure

The law regulating export controls was amended in April 2020 (R.D. 494/2020, 28 April). As a result, the Interministerial Committee for Trade and Control of Defence Equipment and Dual-Use Technologies (Junta Interministerial para el Comercio y Control del Material de Defensa y Tecnologías de Doble Uso, JIMDDU), which is in charge of assessing export authorization, may, exceptionally, establish mechanisms for verification, monitoring and collaboration with respect to the goods exported in particular operations with the collaboration of the Government of the importing country. As a consequence of this amendment, a new EUC template was produced with the addition of a verification clause.
