Land violations committed in November 2021

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
1 November	–	Landmines left behind by the Israeli enemy were detonated as follows: 4 in Alma al-Sha'b, 31 in Marwahin and 3 in Bustan.
	1230	In occupied Palestinian territory, opposite points B64 and B65 and the town of Mays al-Jabal in the Kurum al-Shiraqi area, an Israeli enemy foot patrol consisting of 29 soldiers approached. They opened the metal gate in the technical fence opposite point B64, crossed fence and searched the area between the fence and the Blue Line without breaching the latter, escorted by a Merkava tank. They then took up combat positions behind the earthen berm and pointed their weapons at Lebanese Army personnel located on the other side inside Lebanese territory. The patrol left in the direction of occupied territory at 1420 hours.
2 November	–	Landmines left behind by the Israeli enemy were detonated as follows: 11 in Mays al-Jabal, 8 in Alma al-Sha'b, 14 in Dahirah, 31 in Hula, 8 in Amra and 16 in Yarun.
	0700	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 15 uniformed soldiers approached. They conducted a patrol along the dirt road from the aforementioned point to point TP37. Then, several of the patrol members opened the metal gate in the technical fence, whereupon five patrol members took up positions inside the emplacement located at the site, while the other 10 took up positions along the dirt road and pointed their weapons towards Lebanese territory.
	1505	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), Israeli enemy soldiers pointed their weapons at Lebanese army personnel.
	2000– 2030	Inside the occupied Shab'a Farms, Israeli enemy soldiers fired two flares over the Summaqah position inside occupied Lebanese territory.
3 November	–	Landmines left behind by the Israeli enemy were detonated as follows: 27 in Mays al-Jabal, 4 in Alma al-Sha'b, 9 in Dahirah, 26 in Marwahin, 1 in Hula, 32 in Amra and 41 in Yarun.
	0730	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 16 uniformed soldiers approached. They conducted a patrol along the dirt road from the aforementioned point to point TP37. Then, several of the patrol members opened the metal gate in the technical fence, whereupon 10 patrol members took up positions inside the emplacement located at the site, while the other six took up positions along the dirt road and pointed their weapons towards Lebanese territory.

	0730	Explosions of unknown origin were heard from inside the occupied Shab'a Farms.
	1000	In occupied Palestinian territory, opposite the town of Sahl al-Khiyam near point B90, an Israeli enemy patrol consisting of three civilian cars approached. Four individuals in civilian and military clothing stepped out, scouted the area and took photographs of the Lebanese side. They left in the direction of occupied territory at 1035 hours.
	1315	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), seven Israeli enemy soldiers pointed their weapons at Lebanese army personnel.
	1520	In occupied Palestinian territory, near the town of Ayta al-Sha'b, four Israeli enemy soldiers pointed their weapons towards Lebanese territory.
	1550	In occupied Palestinian territory, opposite the town of Sahl al-Khiyam near point B90, an Israeli enemy civilian bus approached. Some 40 individuals in civilian and military clothing stepped out, scouted the area and took photographs of the Lebanese side. They left in the direction of occupied territory at 1420 hours.
	1955	In occupied Palestinian territory, opposite the town of Ayta al-Sha'b, at the Israeli enemy Tall al-Rahib position, two soldiers directed two searchlights towards Lebanese territory until 2030 hours.
4 November	–	Landmines left behind by the Israeli enemy were detonated as follows: 28 in Mays al-Jabal, 4 in Alma al-Sha'b, 7 in Dahirah, 17 in Marwahin, 2 in Bustan, 35 in Hula, 9 in Arab al-Luwayzah, 7 in Amra and 28 in Yarun.
	0730	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 16 uniformed soldiers approached. They conducted a patrol along the dirt road from the aforementioned point to point TP37. Then, several of the patrol members opened the metal gate in the technical fence, whereupon 10 patrol members took up positions inside the emplacement located at the site, while the other six took up positions along the dirt road and pointed their weapons towards Lebanese territory.
	1500	In occupied Lebanese territory, opposite the town of Udaysah near point TP36(2), an Israeli enemy civilian bus approached. Some 40 individuals in civilian and military clothing stepped out, scouted the area and took photographs of the Lebanese side. They left in the direction of occupied territory at 1530 hours.
	2215	In occupied Palestinian territory, opposite Sahl al-Khiyam at point B90, an Israeli enemy patrol consisting of a Humvee and a jeep approached. Members of the patrol fired three rounds into the air towards Lebanese territory. No one was harmed in the incident. The patrol left in the direction of occupied territory at 2250 hours.
5 November	–	Landmines left behind by the Israeli enemy were detonated as follows: 26 in Mays al-Jabal, 4 in Alma al-Sha'b, 12 in Dahirah, 31 in Marwahin, 7 in Bustan, 20 in Amra and 29 in Yarun.

	1615	In occupied Palestinian territory, opposite the town of Kafr Killa at point B82, an Israeli enemy civilian bus and car approached. Some 35 individuals in civilian clothing stepped out, scouted the area and took photographs of the Lebanese side. They left in the direction of occupied territory at 1655 hours.
6 November	1440	In occupied Palestinian territory, opposite the town of Udaysah near point TP37, seven Israeli enemy military vehicles approached. Some 25 personnel in military clothing stepped out, scouted the area and took photographs of the Lebanese side. They left in the direction of occupied territory at 1530 hours.
7 November	0700	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 14 uniformed soldiers approached. They conducted a patrol along the dirt road from the aforementioned point to point TP37. Then, several of the patrol members opened the metal gate in the technical fence, whereupon 10 patrol members took up positions inside the emplacement located at the site, while the other four took up positions along the dirt road and pointed their weapons towards Lebanese territory.
8 November	–	Landmines left behind by the Israeli enemy were detonated as follows: 23 in Mays al-Jabal, 4 in Alma al-Sha'b, 14 in Marwahin and 21 in Yarun.
	0700	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 14 uniformed soldiers approached. They conducted a patrol along the dirt road from the aforementioned point to point TP37. Then, several of the patrol members opened the metal gate in the technical fence, whereupon 10 patrol members took up positions inside the emplacement located at the site, while the other four took up positions along the dirt road and pointed their weapons towards Lebanese territory.
	1120	In occupied Palestinian territory, opposite the town of Kafr Killa at the Israeli enemy Jabal al-Tayyarah position, a civilian bus and three civilian cars approached. Some 40 individuals in civilian clothing stepped out, scouted the area and took photographs of the Lebanese side. They left in the direction of occupied territory at 1205 hours.

	0700	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 16 uniformed soldiers approached. They conducted a patrol along the dirt road from the aforementioned point to point TP37. Then, several of the patrol members opened the metal gate in the technical fence, whereupon 10 patrol members took up positions inside the emplacement located at the site, while the other six took up positions along the dirt road and pointed their weapons towards Lebanese territory.

Some 25 individuals in civilian clothing stepped out, scouted the area and took photographs of the Lebanese side. They left in the direction of occupied territory at 1000 hours.
	1110	In occupied Palestinian territory, opposite the town of Aytarun, Israeli enemy soldiers pointed their weapons at Lebanese army personnel.
10 November	–	Landmines left behind by the Israeli enemy were detonated as follows: 6 in Mays al-Jabal, 4 in Alma al-Sha'b, 10 in Dahirah, 5 in Marwahin, 1 in Bustan, 14 in Yarun and 11 in Hula.
	0715	In occupied Palestinian territory opposite the town of Wazzani in the area around OP8, an Israeli enemy patrol consisting of three personnel carriers and a civilian pick-up approached. Some 17 personnel in military uniform and two individuals in civilian clothing stepped out. They opened the metal gate in the technical fence, whereupon two of the personnel carriers crossed the technical fence, took up combat positions, fired camouflage smoke and pointed their weapons towards Lebanese territory. The patrol personnel and two civilians then crossed the technical fence and planted four metal stakes into the ground. The work ended at 1205 hours and the patrol left in the direction of occupied territory.
	0800	In occupied Palestinian territory, opposite the town of Wazzani, two Israeli enemy soldiers pointed their weapons at Lebanese army personnel.
11 November	–	Landmines left behind by the Israeli enemy were detonated as follows: 22 in Mays al-Jabal, 4 in Alma al-Sha'b, 3 in Dahirah, 2 in Marwahin, 22 in Yarun, 5 in Hula, 8 in Arab al-Luwayzah and 29 in Amra.
	1530	In occupied Palestinian territory, opposite the town of Labbunah and points BP4(1) and B9, some 15 Israeli enemy soldiers crossed the technical fence, conducted a foot patrol, deployed at the scene and took photographs of the Lebanese side. They left in the direction of occupied territory at 1700 hours.
12 November	–	Landmines left behind by the Israeli enemy were detonated as follows: 18 in Mays al-Jabal, 3 in Alma al-Sha'b, 9 in Dahirah, 2 in Marwahin, 4 in Bustan, 37 in Yarun, 25 in Hula, 20 in Amra and 2 in Markaba.
14 November	0730	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 13 uniformed soldiers approached. They conducted a patrol along the dirt road from the aforementioned point to point TP37. Then, several of the patrol members opened the metal gate in the technical fence, whereupon eight patrol members took up positions inside the emplacement located at the site, while the other five took up positions along the dirt road and pointed their weapons towards Lebanese territory.

The patrol left in the direction of occupied territory at 1250 hours.
15 November	–	Landmines left behind by the Israeli enemy were detonated as follows: 21 in Mays al-Jabal, 3 in Alma al-Sha'b, 4 in Marwahin, 3 in Bustan, 17 in Yarun, 8 in Hula, 30 in Amra and 10 in Markaba.
	0730	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 15 uniformed soldiers approached. They conducted a patrol along the dirt road from the aforementioned point to point TP37. Then, several of the patrol members opened the metal gate in the technical fence, whereupon 10 patrol members took up positions inside the emplacement located at the site, while the other five took up positions along the dirt road and pointed their weapons towards Lebanese territory.

	0700	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 12 uniformed soldiers approached. They conducted a patrol along the dirt road from the aforementioned point to point TP37.
