Land violations committed in April 2022

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
1 April	–	Landmines left behind by the Israeli enemy were detonated as follows: 32 in Yarun, 6 in Marwahin, 5 in Duhayrah and 12 in Arab al-Luwayzah.
	1530	In occupied Palestinian territory, opposite the town of Udaysah, near point TP35, an Israeli enemy patrol consisting of two Humvee vehicles and a Defender approached. Patrol personnel pointed the machine guns mounted on the vehicles towards Lebanese territory. The patrol left in the direction of occupied territory at 1545 hours.
2 April	1515	In occupied Palestinian territory, opposite the town of Udaysah, near point TP37, an Israeli enemy patrol consisting of a Defender vehicle and a white van approached. Some eight soldiers in military uniform disembarked, scouted the area and took photographs of the Lebanese side. The patrol left in the direction of occupied territory at 1615 hours.
	2323	Israeli enemy personnel fired three flare shells over the Radar position inside the occupied Shab'a Farms.
4 April	–	Landmines left behind by the Israeli enemy were detonated as follows: 32 in Yarun, 20 in Marwahin, 7 in Duhayrah, 15 in Mays al-Jabal, 13 in Alma al-Sha'b and 39 in Hula.
	0800	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of nine soldiers in military uniform approached. They conducted a patrol along the dirt road from the aforementioned point to point TP37, all the while pointing their weapons towards Lebanese territory. Also, a Merkava tank deployed near point TP36(2) pointed its cannon towards Lebanese territory.
5 April	–	Landmines left behind by the Israeli enemy were detonated as follows: 6 in Marwahin, 13 in Duhayrah, 24 in Yarun, 10 in Mays al-Jabal, 16 in Alma al-Sha'b, 38 in Amra and 23 in Markaba.
	1540	In occupied Palestinian territory, opposite the town of Hula, an Israeli enemy group consisting of some 14 soldiers in military uniform approached. They scouted the area and took photographs of the Lebanese side. They left in the direction of occupied territory at 1615 hours.
6 April	–	Landmines left behind by the Israeli enemy were detonated as follows: 9 in Marwahin, 19 in Duhayrah, 26 in Yarun, 11 in Mays al-Jabal, 12 in Alma al-Sha'b, 15 in Amra, 22 in Markaba and 1 in Hula.
7 April	–	Landmines left behind by the Israeli enemy were detonated as follows: 4 in Marwahin, 1 in Duhayrah, 27 in Yarun, 12 in Mays al-Jabal, 18 in Alma al-Sha'b, 15 in Amra, 4 in Markaba and 8 in Hula.

	0700	In occupied Palestinian territory, opposite the town of Wazzani, two trench diggers, a wheeled bulldozer, a Humvee vehicle, three military vehicles, and eight soldiers in military uniform approached. The soldiers performed maintenance work on the technical fence. One of the diggers breached the Blue Line by extending its boom over and across the technical fence, placing seven cement blocks inside Lebanese territory. The work ended at 1100 hours.
	0730	In occupied Palestinian territory, opposite the town of Markaba, an Israeli enemy group consisting of some 10 soldiers in military uniform approached. They scouted the area and took photographs of the Lebanese side. They left in the direction of occupied territory at 0800 hours.
	0810	In occupied Palestinian territory, opposite Sahl al-Khiyam in the vicinity of point BP37(2), an Israeli enemy military vehicle approached. Five soldiers in military uniform disembarked, scouted the area and took photographs of the Lebanese side while a United Nations Interim Force in Lebanon (UNIFIL) liaison unit vehicle was present. The enemy vehicle left in the direction of occupied territory at 0850 hours.
	1130	In occupied Palestinian territory, opposite the town of Wazzani, at the Israeli enemy Humayri position, an Israeli enemy Merkava tank deployed in the vicinity of pole 40 and pointed its cannon towards Lebanese territory until 1230 hours.
8 April	–	Landmines left behind by the Israeli enemy were detonated as follows: 10 in Marwahin, 11 in Duhayrah, 13 in Yarun, 9 in Mays al-Jabal, 10 in Alma al-Sha'b, 24 in Amra, 11 in Markaba, and 14 in Hula.
	1020	In occupied Palestinian territory, opposite the town of Sahl al-Khiyam, an Israeli enemy group consisting of some 40 soldiers in military uniform approached. They scouted the area and took photographs of the Lebanese side. They left in the direction of occupied territory at 1140 hours.
11 April	–	Landmines left behind by the Israeli enemy were detonated as follows: 19 in Yarun, 4 in Marwahin, 14 in Duhayrah, 7 in Mays al-Jabal, 22 in Alma al-Sha'b, 11 in Amra and 24 in Arab al-Luwayzah.
	0800	In occupied Lebanese territory, opposite Ras al-Naqurah, five Israeli enemy civilian army personnel escorted by two soldiers in military uniform crossed the metal fence through the pedestrian gate west of point M2. They installed a metal scaffold between the metal fence and the technical fence, and laid a barbed wire (concertina) strip from the north to east of point M1(1). The work ended and the workers and soldiers left in the direction of occupied territory at 1540 hours.
12 April	–	Landmines left behind by the Israeli enemy were detonated as follows: 13 in Marwahin, 4 in Duhayrah, 35 in Yarun, 7 in Mays al-Jabal, 9 in Alma al-Sha'b, 1 in Arab al-Luwayzah and 32 in Hula.
	1015	In occupied Palestinian territory, opposite the town of Hula, Israeli enemy soldiers pointed their weapons towards Lebanese territory until 1017 hours.
13 April	–	Landmines left behind by the Israeli enemy were detonated as follows: 17 in Yarun, 4 in Marwahin and 6 in Duhayrah.

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
	0830	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 12 individuals in military clothing approached and conducted a patrol along the dirt road from the aforementioned point to point TP37. Then, several of the patrol members opened a metal gate in the technical fence, whereupon six patrol members took up positions inside the emplacement situated at the site, while the other six took up positions along the dirt road and pointed their weapons towards Lebanese territory.
	0910	In occupied Palestinian territory, in the vicinity of point TP36(2), a Merkava tank approached and pointed its cannon towards Lebanese territory.
14 April	–	Landmines left behind by the Israeli enemy were detonated as follows: 13 in Marwahin, 8 in Duhayrah and 30 in Yarun.
	0053	Israeli enemy personnel fired three flare shells that fell in Lebanese territory near the town of Marun al-Ra's.
	0905	In occupied Palestinian territory, opposite the town of Kafr Kila, an Israeli enemy group consisting of some 25 soldiers in military uniform approached. They scouted the area and took photographs of the Lebanese side. They left in the direction of occupied territory at 0945 hours.
	1540	In occupied Palestinian territory, opposite the town of Mays al-Jabal, three Israeli enemy soldiers pointed their weapons towards Lebanese territory until 1630 hours.
15 April	–	Landmines left behind by the Israeli enemy were detonated as follows: 10 in Alma al-Sha'b.
	2055– 2130	Israeli enemy personnel fired three flare shells over the Ruwaysat al-Alam position inside the occupied Shab'a Farms.
17 April	1015	In occupied Palestinian territory, opposite the town of Markaba, an Israeli enemy Merkava tank pointed its cannon towards Lebanese territory until 1115 hours.
19 April	–	Landmines left behind by the Israeli enemy were detonated as follows: 1 in Mays al-Jabal.
20 April	–	Landmines left behind by the Israeli enemy were detonated as follows: 10 in Alma al-Sha'b and 12 in Mays al-Jabal.
21 April	–	Landmines left behind by the Israeli enemy were detonated as follows: 24 in Yarun, 10 in Mays al-Jabal, 7 in Alma al-Sha'b and 3 in Naqurah.
22 April	–	Landmines left behind by the Israeli enemy were detonated as follows: 8 in Mays al-Jabal, 7 in Alma al-Sha'b and 3 in Naqurah.
23 April	2245	Opposite the town of Kafr Kala in the vicinity of point B84, Israeli enemy soldiers fired five flares, four of which landed inside Lebanese territory and one inside occupied territory.

25 April	0145	The Israeli enemy fired artillery and flare shells towards Lebanese territory in three stages: Some 25 artillery shells were fired at the outskirts of the town of Zibqin, west of Jabal Bassil; Some 25 artillery shells were fired at the outskirts of the town of Tayr Harfa; Some 40 flare shells were fired above Tayr Harfa, Naqurah, Bidyas and Shihin. The bombardment ended at 0400 hours.
	1030	In occupied Palestinian territory, opposite the town of Kafr Kila, an Israeli enemy group consisting of some 25 soldiers in military uniform approached. They scouted the area and took photographs of the Lebanese side. They left in the direction of occupied territory at 1130 hours.
26 April	–	Landmines left behind by the Israeli enemy were detonated as follows: 5 in Mays al-Jabal, 7 in Alma al-Sha'b and 5 in Naqurah.
27 April	–	Landmines left behind by the Israeli enemy were detonated as follows: 10 in Mays al-Jabal, 11 in Naqurah and 11 in Alma al-Sha'b.
	0650	From inside the Israeli enemy position east of Mays al-Jabal, a Merkava tank pointed its cannon towards Lebanese territory.
28 April	–	Landmines left behind by the Israeli enemy were detonated as follows: 10 in Marwahin, 12 in Duhayrah, 5 in Mays al-Jabal, 5 in Naqurah and 8 in Alma al-Sha'b.
	1530	At Jabal al-Shahal, on the outskirts of the town of Shab'a, while Lebanese civilian Mahir Faris Hamdan was herding livestock, an Israeli enemy patrol abducted him and took him into the occupied Shab'a Farms.
29 April	–	Landmines left behind by the Israeli enemy were detonated as follows: 11 in Marwahin and 6 in Duhayrah.

Crew members broadcast over loudspeakers in Hebrew. The launch then left in the direction of occupied Palestinian territorial waters.
4 April	0814	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for 26 minutes, proceeding on its way for some 241 m. The launch then left in the direction of occupied Palestinian territorial waters.
	2127	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for 17 minutes, proceeding on its way for some 370 m. The launch then left in the direction of occupied Palestinian territorial waters.
5 April	0533	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for five minutes, proceeding on its way for some 278 m. The launch then left in the direction of occupied Palestinian territorial waters.

6 April	1450	An Israeli enemy reconnaissance aircraft violated Lebanese airspace, entering over the sea west of Beirut. It circled over Beirut and its suburbs, Ba'abda and Alayh, before leaving at 1625 hours over the sea west of Beirut.
9 April	1840	Four Israeli enemy warplanes violated Lebanese airspace, entering over the sea off Juniyah and heading as far as Arz, before leaving at 1858 hours over the sea west of Naqurah.
10 April	1355	An Israeli enemy reconnaissance aircraft violated Lebanese airspace, entering over the sea off Khaldah. It circled over Juniyah, Matn, Ba'abda and Beirut and its suburbs, before leaving at 1900 hours over the sea off Damur.
16 April	1030	An Israeli enemy fixed-wing aircraft violated Lebanese airspace, entering over the occupied Shab'a Farms. It circled at low altitude over the Israeli enemy Ramtha and Zabdin positions, before leaving at 1100 hours in the direction of occupied territory.
	2145	An Israeli enemy reconnaissance aircraft violated Lebanese airspace, entering over Naqurah. It circled over the South, before leaving at 2230 hours over Hasbaya.
23 April	2310	An Israeli enemy drone violated Lebanese airspace, entering from inside occupied Palestinian territory opposite the town of Kafr Kila. It proceeded on its way for some 100 m. and circled over the town, before leaving at 2315 hours in the direction of occupied territory.
25 April	2235	Four Israeli enemy warplanes violated Lebanese airspace, entering over the sea west of Juniyah and heading as far as Jubayl, before leaving at 2240 hours over the sea west of Jubayl.
26 April	1250	An Israeli enemy reconnaissance aircraft violated Lebanese airspace, entering over the sea off Beirut. It circled over Beirut and its suburbs, Ba'abda, Alayh and Matn, before leaving at 1640 hours over the sea off Beirut.
