Letter dated 22 June 2022 from the Secretary-General addressed to the President of the Security Council

I have the honour to refer to your letter dated 15 June 2022 ([S/2022/487](#)) in which you concurred with my proposal to reappoint the 25 judges of the International Residual Mechanism for Criminal Tribunals.

I have received a corresponding letter from the President of the General Assembly (see annex I). Accordingly, I am proceeding with the reappointment of the 25 judges of the Mechanism. A list of the judges is set out in annex II to the present letter.

In accordance with paragraph 2 of Security Council resolution [2269 \(2016\)](#), adopted on 29 February 2016, the judges will be reappointed for a two-year term commencing on 1 July 2022 and expiring on 30 June 2024.

I will also proceed to appoint Judge Graciela Susana Gatti Santana (Uruguay) as President of the Mechanism from 1 July 2022 to 30 June 2024.

I should be grateful if you would bring the present letter and its annexes to the attention of the members of the Security Council.
