ESTABLISHMENT OF THE EAST AFRICA HIGH COMMISSION,  
ITS SERVICES AND ITS ADVISORY AND CONSULTATIVE BODIES  
Addendum to the memorandum prepared by the Secretariat

Page 3: third line, top of page, add the following:

"By the High Commission Promulgation No. 1 of 22 February 1949, the East Africa Central Legislative Assembly has been prorogated with effect from 14 April 1949.

"By the High Commission Promulgation No. 2 of 22 February 1949, a meeting of the said Assembly has been convoked on 26 April 1949 to be held at Kampala, Uganda. (Official Gazette of the East Africa High Commission, Vol. II - No. 3, pp. 25-26)."

Page 10: line 15 (I. Makerere College), add the following:

"The Makerere College Act No. 2 of 1949 assented to by the High Commission on 24 February 1949 which came into operation on 11 March 1949 contains provisions concerning the constitution, and aims of the College, functions of its Council and Academic Board, staff provisions and financial provisions. (Official Gazette of the East Africa High Commission, Vol. II - No. 4, p. 31, and pp. 18-35.)"

Page 10: add the following:

"L. The East African Revenue Advisory Board

"By Order of the East Africa High Commission, dated 24 February 1949 the East African Revenue Advisory Board has been appointed and constituted as follows:

- "(a) the Chairman, who shall be the person exercising for the time being the functions of the Finance Member;
- (b) The Vice-Chairman, who shall be the person exercising for the time being the functions of the Economic Secretary;
- (c) three official members, one to be appointed on the nomination of each of the Governors of Kenya, Tanganyika and Uganda;
- (d) six unofficial members -

/(1) two to be

- (i) two to be appointed on the nomination of the Governor in Council of Kenya;
- (ii) two to be appointed on the nomination of the Governor of Tanganyika;
- (iii) two to be appointed on the nomination of the Governor in Council of Uganda;
- (e) one member to be appointed on the nomination of the British Resident, Zanzibar.

"In accordance with Section 3 of the said Order the functions of the Board shall be to consider and advise the High Commission on any of the following matters on which the High Commission may consult the Board -

- "(a) any matter relating to the administrative and general provisions of the laws relating to income tax and customs and excise;
  - (b) all Bills which it is proposed to introduce into the Assembly relating to income tax and customs and excise;
  - (c) any matter relating to the establishment or organization of the East African Income Tax Department and the East African Customs and Excise Department;
  - (d) any question of general policy in connexion with the administration, control and organization of the said two Departments;
  - (e) such other matters as the High Commission may refer to it.

"M. The East African Advisory Council on Agriculture, Animal Industry and Forestry.

"By the High Commission Notice No. 19 of 20 January 1949, the High Commission appointed an East African Advisory Council on Agriculture, Animal Industry and Forestry consisting of:

- The Administrator, East Africa High Commission (Chairman).
- The Scientific Secretary, East Africa High Commission (Deputy Chairman).
- The Member for Agriculture and Natural Resources, Kenya.
- The Member for Agriculture and Natural Resources, Tanganyika.
- An official appointed by the Government of Uganda.
- The Directors of Agriculture, Kenya, Tanganyika, Uganda and Zanzibar.
- The Directors of Veterinary Services, Kenya, Tanganyika and Uganda.
- The Conservators of Forests, Kenya, Tanganyika and Uganda.

/An unofficial

An unofficial representative of agriculture and natural resources from Kenya, from Tanganyika and from Uganda.

A representative of the Overseas Food Corporation.

A representative of the Empire Cotton Growing Corporation.

The Director of the East African Agricultural and Forestry Research Organization.

The Director of the East African Tsetse and Trypanosomiasis Research and Reclamation Organization.

The Director of the East African Veterinary Research Organization.
