**AGREEMENT BETWEEN
THE REPUBLIC OF MALDIVES AND THE REPUBLIC OF MALAWI
ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS**

The Republic of Maldives and the Republic of Malawi,

Desiring to strengthen and develop relations between Maldives and Malawi in accordance with the purposes and principles of the Charter of the United Nations, in particular the respect for and promotion of international peace and security, equality among states, due respect for national sovereignty and territorial integrity, independence and international treaties, and non-interference in the internal affairs of States;

Have agreed as follows:

Article 1

Maldives and Malawi shall, on the date on which this Agreement enters into force, establish diplomatic relations with each other and shall exchange diplomatic representatives as soon as possible on non-residential basis.

Article 2

The Parties to this Agreement agree that the provisions of the Vienna Convention on Diplomatic Relations of 18 April 1961 shall apply to diplomatic relations between them.

Article 3

The Parties to this Agreement agree that the provisions of the Vienna Convention on Consular Relations of 24 April 1963 shall apply to consular relations between them.

Article 4

This Agreement shall enter into force at the time of its signature.
