**JOINT COMMUNIQUÉ
ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS
BETWEEN

The Government of Jamaica and the Government of the Republic of the Marshall Islands,

Desirous of developing and promoting friendly, peaceful and cooperative relations between the two countries in the political, economic, social, humanitarian, cultural and scientific fields,

In accordance with the principles and purposes of the United Nations Charter and the provisions of the Vienna Convention on Diplomatic Relations of 18th April 1961,

Have decided to establish diplomatic relations at the Foreign Minister Level, as of the date of signing of this Joint Communiqué.

In witness thereof, the undersigned representatives, duly authorized by their respective Governments, have signed this Joint Communiqué, in New York, on 23rd September 2022 in duplicate, both texts being equally valid.
